C. USA Swimming Junior Official Program

 - a. Must be 16-17 years old.
 - b. Must be a registered member, with no additional cost if already registered as an athlete.
 - c. Sessions are limited to 12&under sessions, where the Official did not also compete.
 - d. Each Jr Official must be paired with a registered Official (1:1).

iv. Training required:

- i. Same as adult Officials.
- ii. Safe Sport for Youth Athletes (replaces APT training until age 18).
- iii. Concussion Training.
