## I. Term Limits

- a. The terms of office of all members of the BOD shall be two years.
- Except for Secretary, Officials Chair, and the Treasurer, no Individual Member who has served two successive terms shall be eligible for re-election or appointment to the same position until a lapse of one term.
- c. A portion of any term served to fill a vacancy in the position shall not be considered in the computation of this successive terms limitation.

## II. Appointed Positions by the General Chair

- a. The BOD shall have the power and it shall be its duty to provide advice and consent to appointments proposed by the General Chair as required under the Bylaws or the WISI Policies and Procedures.
- b. The term of ex-officio position holders appointed by the General Chair ends with the start of a new General Chair, at which time the position holder may be reappointed or a new individual appointed.
- c. There are no term limits for these positions, except for the Governance Chair (4 year term with 1 re-appointment).
- III. **Ex-officio Members** have voice, but no vote.
- IV. **Office held by Two Persons** Any office other than General Chair, Finance Vice-Chair and Treasure may be jointly held by two Individual Members. Two individuals who are sharing an office shall share one vote.

V. **Offices Combined** - Any office other than General Chair may be combined with any other office except that the Offices of Finance Vice-Chair and Treasurer may not be combined.
