AGENDA/MINUTES

- 1. Review CAC Discussion on LC State Meets
 - LC 13+ State Meet
 - CAC has suggested to: tighten standards, especially in 13-14 age group, drop to 1+2 bonus formula, 2+2 relay swimmers, A/B only, 13-14 plus senior relays.

TP approved moving 13+ LC meets back to 2022 standards along with all other items mentioned above.

TP further approved moving all admin paperwork to "paper" format versus online forms. This includes downseeds and scratches.

TP also approved using a "positive-check" format for the LC 13+ state meet in 2023. Swimmers will have to positive check within the same timeline as the scratch rule.

- LC 12u State Meet
 - CAC has suggested to offer 8u events in all four 50s and the 100 free. 8u
 cut times would be needed but would swim within the 10u events.

TP approved all items listed above.

- Qualification Periods
 - o Brian suggest to make all meets 18 months.

TP approved all champ meets having an 18-month qualification window.

- 2. Review CAC Discussion on Order of SCY State Meets
 - A majority of the CAC has voiced the idea to use the same weekend format for SC state meets.

TP approved using the same weekend format for 2024 SC state meets.

3. Review CAC Discussion on Regional Meets

 The group was somewhat split on which age groups were win and in. Consensus to eliminate 200+ events. There was a slight preference to have 12u, 9-10, and 8u.

TP moved to have the "win and in" option available for only 8u and 9-10 events 100 yards or less. This was approved unanimously. 11-12 events WILL NOT have a "win and in" option.

- 4. Review CAC Discussion of 10u State Meet
 - Potential tightening of time standards for 2024. BT not sure that is necessary.
 - BT suggests clearer communication with potential host for needs to have a secondary area for swimmers and a potential later start time form Saturday.
 - Teams know what to expect now.
 - NTs at state meet?

- 5. Review CAC Discussion of Senior State Meet (possible...tabled!)
 - Distance should only be fast to slow at the end of a session.
 - 400 IM should not be fast to slow.
 - Top 16 relays to PM finals.

 - Only bring back one heat of 11-12 stroke 200s+
 - Relay Breaks
 - Relays Started Sessions/Ended Finals??

TP tabled this item.

- 7. Discussion of Records
 - Meet Records only suggested for stroke 50s and 100 IM.

TP agreed that meet records should be kept but no additional recognition is needed above and beyond what USA swimming recognizes.
