## Policy 13: Athlete **Board** Representatives and the Athlete Liaison

Effective Date: *May 1, 1998* Supersede Date: *New* 

Last Revision Date: February 4, 2014, October 24, 2023

**Scope:** This policy is written for Athlete Members for the purpose of providing the procedure for electing their Athlete <u>Board</u> Representatives and to outline the responsibilities of the Athlete <u>Board</u> Representatives and <u>the Athlete Liaison</u>.

#### 13.1 Athlete **Board** Representatives

13.1.1 There shall be four (4) Athlete <u>Board</u> Representatives elected, two (2) each year, serving a (2) year term or until his/her successor is elected.

13.1.2 The two (2) Senior Athlete Board Representatives shall co-chair the Athlete
Committee and Athlete Division. There shall be one (1) Senior Athlete Repetitive
appointed by the Senior Committee Chair.

#### 13.2 Athlete **Board** Representative Responsibilities

13.2.1 Elected Athlete **Board** Representatives:

- A. Serve as an intermediary between the athletes who are members of Wisconsin Swimming and the Board of Directors and House of Delegates; and
- B. Shall participate <u>in the meetings of the Board of Directors</u>, the House of <u>Delegates</u>, and the Athlete Committee. annually in the January and April LSC House of Delegates Meetings and two (2) of the regularly conducted Board of <u>Directors Meetings</u> and represent the LSC at the annual USA Swimming <u>Convention</u>. If an Athlete Representative is unable to attend one of the aforementioned meetings, they shall inform the Senior Athlete Representative and the Senior Committee Chair and obtain a replacement to attend the meeting on his/her behalf.

13.2.2 Senior Athlete **Board** Representatives:

- B. Conducts at least one (1) meeting annually, which is usually at the annual LSC House of Delegates meeting or in conjunction with the 13 & Over LSC Short or

Long Course Championships for Athlete Members or Seasonal Athlete Members ages 13 or older, to assess the needs and interests of LSC athletes; and

C. Conducts the election for the two (2) Athlete **Board** Representatives each year.

#### 13.3 Eligibility for Elected Athlete **Board** Representatives

At the time of the election, the Athlete Representative must be:

- A. An Athlete Member or Seasonal Athlete Member in good standing;
- B. At least sixteen (16) years of age or have sophomore status in high school;
- C. Competing currently, or have competed during the two (2) three (3) immediately preceding years in the program of swimming, conducted by Wisconsin Swimming or another LSC; and
- D. Shall have his/her place of permanent residency in the Territory and is expected to reside therein through at least the first half of the term, other than for periods of enrollment in an institution of higher education.

#### 13.4 Election Procedure

- 13.4.1 The election of Athlete <u>Board</u> Representatives shall be conducted annually by the Senior Athlete <u>Board</u> Representatives at the LSC Short Course Championships, or at another regularly scheduled meet, designated by the Board of Directors. The election shall be conducted as follows:
  - A. The Senior Athlete <u>Board</u> Representatives shall <u>post announce the election at the January LSC House of Delegates meeting and have posted</u> on the LSC website an announcement of the Athlete <u>Board</u> Representative elections <u>date</u>, the election procedures, and an <u>e-mail</u> address to which nominees must send their statements by a specified date.
  - B. Each nominee shall send a statement of no more than two hundred (200) words explaining why he/she wishes to become an Athlete Board Representative to the Senior-Athlete Board Representatives.
  - C. The Senior Athlete <u>Board</u> Representatives shall make a ballot with all the nominees' names and their statements to send to the 13 & Over LSC Short Course Championships Meet Director.
  - D. The Meet Director shall make enough copies of nominations, including nominees' statements, for one (1) ballot. These statements <u>are</u> to be supplied in each coach Meet packet, along with the total number of Athlete Members and Seasonal Athlete Members ages 13 or over by team that are eligible to vote;
  - E. Each Coach shall submit the numeric count for each nominee, on a marked ballot, to the Senior Athlete <a href="Board">Board</a> Representatives. This must be done so prior to the beginning of the final session of the Meet. The Club's numeric count may add up to the Club's total number of Athlete Members and Seasonal Athlete Members eligible to vote, whether all those Athlete Members or Seasonal Athlete Members are present at the Meet. A Club's votes can be based on the vote of athletes that are present at the Meet or prior to the Meet.
  - F. The nominees with the most votes shall be declared/announced the "new" elected Athlete <u>Board</u> Representatives before the conclusion of the Meet.

13.4.2 The term of office for an elected Athlete <u>Board</u> Representative shall begin with the date of his/her election and shall terminate after the two-year term or with the election of a successor.

#### 13.5 Voter Requirements

- 13.5.1 An Athlete Member eligible to vote shall be:
  - A. An Athlete Member or Season Athlete Member in good standing who is a member of the USA Swimming and Wisconsin Swimming;
  - B. At least thirteen (13) years of age or older at the time the election takes place.

#### 13.6 Early Vacancy

In the event of a vacancy in an elected Athlete <u>Board</u> Representative position before completing his/her term, the General Chair may appoint, with the advice and consent of the Board of Directors, an Athlete Member to serve the remainder of the term of office.

#### 13.7 Athlete Liaison

There shall be one (1) Athlete Liaison appointed by the Senior Athlete <u>Board</u> Representatives and Senior Committee Chair, with approval of the Board of Directors, to be announced at the annual LSC House of Delegates meeting.

#### 13.8 Athlete Liaison Responsibilities

- 13.8.1 The Athlete Liaison works with the Senior Athlete **Board** Representatives to:
  - A. Assist the Athlete <u>Board</u> Representatives with improving communication and engagement between themselves and Athlete Members within Wisconsin Swimming:
  - B. Assist the Senior Athlete <u>Board</u> Representatives in the coordination of at least one (1) meeting annually, usually at the annual LSC House of Delegates meeting or in conjunction with the 13 & Over LSC Short or Long Course Championships for Athlete Members or Seasonal Athlete Members ages 13 or older, to assess the needs and interests of LSC athletes;
  - C. Assist the Senior Athlete <u>Board Representatives</u> and Senior Committee Chair with conducting the elections of two (2) Athlete <u>Board Representatives</u> each year;
  - D. Advisee and assist when it is appropriate to present any agenda item(s) to athlete members and/or the Board of Directors or LSC House of Delegates; and
  - E. Provide guidance to ensure the successful execution of the goals and responsibilities of the Senior Athlete <u>Board</u> Representatives.

#### 13.9 Eligibility for Athlete Liaison

- 13.9.1 At the time of appointment, the Athlete Liaison-shall must:
  - A. Be 1921 years or older;
  - B. Be an athlete or non-athlete member of USA Swimming and Wisconsin Swimming; and

C. Fulfill all required background screenings as mandated by USA Swimming, which includes the annual online Athlete Protection Training and Level 2 Criminal Background Check.
