General Meeting: The General Meeting will be held virtually on Thursday, February 29th at 6:30 pm. It will be recorded and posted on the host's website. Additional coaches' meetings may be held as determined by the Meet Referee. It is the responsibility and obligation of each team or unattached swimmer to be represented at all coaches' meetings. Coaches or other team representatives are responsible for all information presented at these meetings including changes to the meet format or conduct. Coaches should check their team mailboxes prior to each session and look for postings where they pick up heat sheets.

Facility: One 10-lane, 25-yard pool with a minimum depth of 7' throughout the competition course will be in use during prelims and finals. The starting blocks are 30" high and are equipped with track-style wedges. The Wisconsin LSC (Meet Host) will ensure the required course dimensions are met. The pool uses a fully automatic Colorado System 7 timing system with a full video display board, beep starts, and touch pads on the starting end of the pool. Two buttons and two stopwatches will be used for back-up times.

Scratch Table: All scratches, including scratches for finals, will be done online. More information will be presented at the coaches meeting and on the Meet Landing Page.

Deck Access: Deck access is restricted to participating athletes, coaches, working officials and other meet personnel (marshalls, timers, etc.) Authorized personnel will be issued a credential tag which must be displayed at all

times when on the pool deck. Coaches must be in good standing and show proof of current membership prior to the start of each session in the Shark Room. The official mobile application of USA Swimming should be used for proof of USA Swimming membership.

**Spectator Admission:** Spectators will be allowed. Heat sheets will be available for free on the meet landing page and Meet Mobile. Restrooms will be available in the pool lobby and seating balcony. The meet will be live streamed via LiveBarn. The link will also be posted on the meet landing page.

**Concessions:** Concessions are available in the RecPlex main lobby.

**Lost and Found:** Please check the lost and found area, near the entrance to the girls and boys locker rooms. The facility and the meet host are not responsible for lost items. Items not picked-up by the end of the meet will be discarded or donated.

### **RULES AND PROCEDURES**

**Official Rules:** Official Current USA Swimming and Wisconsin LSC rules shall prevail for this meet except as otherwise specified in this meet information. Swimmers must be registered USA Swimming athletes. Deck registrations are not allowed. Athlete age will be determined as of March 1, 2024. All Coaches and Officials are required to check in and prove that their USA Swimming Membership is in Good Standing. The official mobile application of USA Swimming is acceptable proof of USA Swimming membership.

**PARA Athletes:** Athletes with a disability should submit the Wisconsin Swimming Accommodation/Modification form to the Meet Referee or Meet Director, prior to the start of the meet, to communicate any special requirements and/or requests. All requests for swimmers with disabilities must be received before the start of the meet.

**MAAPP Acknowledgement:** All applicable adults participating or associated with the respective meet to which this information applies, acknowledge that they are an applicable adult, subject to the provisions of USA Swimming's MAAPP, and that they understand that compliance with the MAAPP Policy is a condition of participation in the conduct of this competition. Times achieved by an athlete member at a sanctioned/approved meet who is 18 years of age or older, who had not completed the Athlete Protection Training (or whose APT training had expired) by the date of the swim, will not be able to be uploaded to SWIMS.

**Start Certification:** Any swimmer entered in the meet must be certified by a USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water. Further, those participants not proficient with a backstroke ledge may not use the backstroke ledge. When unaccompanied by a member-coach, it is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.

**Protests:** For consideration of all protests lodged at the meet, the Meet Referee may appoint a meet jury. The jury shall consist of not fewer than three (3) and not more than five (5) persons, at least one of whom shall be a coach and one an athlete.

### WARM-UP AND MEET SCHEDULE

- PRELIM WARMUPS:** Friday-Sunday Prelim warm ups start at 7:00AM with meet starting at 8:35AM. Depending on size of meet and timeline, these warm up times may be adjusted by meet management and teams will be notified once all entries have been received.
- FINALS:** Friday-Sunday Finals: Finals warmups will not begin before 5 PM on Friday and Saturday and not before 4 PM on Sunday. Timeline for warm-ups and finals will be published once all entries have been received and teams will be notified.
- Pre-Session Warm-Up:** Warm up times and lanes for both prelims will be assigned unless otherwise noted. Assignments will be posted on the meet landing page and communicated accordingly to the "lead" coach for each team.
- Circle swimming only, entry into the water shall be feet first three-point entry for all competition, except in designated lanes and times. All entry to pools during open warm-up cool down periods must be from the start end. Teams should plan to do starts, sprint and pace work within their assigned warm-up time. No snorkels, kickboards or other training devices are allowed during warm-ups.
- Swimmer(s) without a coach present are to report to the Meet Director prior to warm-ups for lane assignment.
- In-Meet Warm-Up:** Four lanes will be open in the pool water park side pool for warm-up/warm-down breaks. A limit of 10 swimmers per lane will be allowed in these lanes during competition. Prior to timed final distance events additional lanes may be opened for warm ups.

### ENTRY INTO THE MEET

- Swimmer Eligibility:** All swimmers must be registered athlete members of USA Swimming and Wisconsin Swimming, and be in good standing. All individual swimmers entered in the meet shall be eligible to swim in the meet, having at least one verifiable qualifying time. Swimmers who cannot verify qualification for the meet with a proof of time will be withdrawn from the meet. Any swimmer who swims in the meet and is found ineligible will be disqualified from the meet, forfeit all awards and points achieved and their club fined \$200. There will be no deck entries or registration. The representative submitting entries shall be responsible for verifying that all swimmers satisfy these requirements.
- Qualifying Times:** **QUALIFYING TIMES MUST BE ACHIEVED AFTER SEPTEMBER 1<sup>ST</sup>, 2021.** Qualifying time standards can be found on [www.wisconsinsswimming.org](http://www.wisconsinsswimming.org) - under Events - Championship Meets. Qualifying times will be accepted in Short Course Yards, Short Course Meters, or Long Course Meters.
- Seeding:** Non-conforming times will be seeded after SCY times. The order used for seeding will be SCY-SCM-LCM. Bonus entries will be seeded after qualified swims in the same order.
- PARA ATHLETES:** Swimmer athletes can enter any event (up to the limit of the meet information) but they must have achieved a Wisconsin Swimming State Time Standard OR the Disability Para Motivational Championship

Time Standards (P1, P2, P3). Both sets of time standards can be found on Wisconsin Swimming's website ([www.wisconsinswimming.org](http://www.wisconsinswimming.org)). Although swimmers with disabilities can enter any event(s) the only events that will be scored and awarded in Para categories are noted on the event page.

When entering an athlete with a disability to the designated Disability events or any other events, email the Entry Chair so they can be verified and seeded properly. If coaches have any questions regarding the Disability inclusion at the State Championship, please email Wisconsin Swimming's Disability Chair. Information can be found on the Wisconsin Website ([www.wisconsinswimming.org](http://www.wisconsinswimming.org)).

Meet Management may combine entries based on gender and/or age groups.

*USA Swimming defines a Disability as a permanent life affecting impairment/disability. This would include everything from a club foot through to children on the spectrum where it affects their reaction times, severe learning disabilities, etc and everything in between. The two key components are that it must be permanent (recovery from surgery, a bad sprain, etc is not acceptable) and it must affect their performance.*

Age Groups: There will be two age groups: 11-12 and 13-14 (1650Y Free will be 11-14).

Athletes MUST swim their conforming age during the duration of the meet.

Entry Limits: A swimmer may compete in not more than six (6) individual events total for the meet, limited to three (3) individual events per day, excluding time trials events. Athletes can enter any/all qualifying events but must scratch down to 3/day and 6/Meet. A swimmer may compete in no more than three (3) individual events per day including time trial events. Time trials are under a separate sanction and therefore DO NOT fall under the six (6) events for the meet but DO fall under the total of three (3) events per day as mandated by USA Swimming.

Bonus Events: Any swimmer who has entered with one qualifying time may enter three bonus events for which they do not have a qualifying time. Any swimmer entered with two qualifying times may enter two bonus event and any swimmer entered with three qualifying times may enter one bonus event. A swimmer must be qualified, by time and age restrictions, in an age group to earn a bonus swim in that age group.

Relay Events: A Relays (must consist of at least two (2) individual qualifiers + two (2) Relay-Only.

B Relays (8) Qualifiers, C Relays (12) Qualifiers, etc.

Downseeding will be allowed for the 400/800 Yard Relays.

Relay-only swimmers must be included in your entry. To add a relay-only swimmer after the entry deadline, the swimmer must be entered in the meet 30-minutes prior to the start of the session in which they will swim.

### **ENTRY PROCEDURE:**

- **INITIAL ENTRY DEADLINE:** THURSDAY, FEBRUARY 22<sup>nd</sup>, 2024 – will close at 10:00 PM CT.
- **PLEASE NOTE:**  
**50Y of stroke for the 13-14 events (Backstroke, Breaststroke and Butterfly) MUST enter at the qualifying 100Y Time – PLEASE ENTER AT 100Y TIME, likewise the 13-14 100Y Individual Medley MUST enter at the qualifying 200Y Individual Medley time.**  
**11-12 year olds must enter at their 50Y of stroke qualifying time this also includes the 100Y Individual Medley.**
- Entries missing the deadline may be accepted upon remittance of a \$100 late fee. Entries submitted after 6:00 PM CST on Tuesday, February 27<sup>th</sup>, 2024 will not be accepted.
- **Psych Sheet WILL NOT be posted until Wednesday, February 28th, 2024. Only changes for administrative errors are allowed after the Psych sheet is posted.**
- **PAYMENT:** A non-refundable check for entry fees and surcharges must be received before the start of the meet. All payments will be made via check or cash, no credit cards will be accepted. All express mail must be pre-signed, so it will not require a signature for delivery. **Make checks payable to Wisconsin Swimming, Inc.**
- Winter Regional 11-12 Year old Athletes that Win your event but do not achieve the Qualifying Time standard, please be sure to include in your entries - these athletes should be entered into the meet at the SCY Qualifying time and noted as such with your entries.
- When entering a disabled athlete into the meet, please be sure to include any needed documentation used to determine P1, P2 or P3 designated disability placement. Proof of Time: Reference POLICY 2.7.4 in the Wisconsin Policy manual for Rules and Procedures:

A swimmer, who does not swim equal to or faster than the meet qualifying time standard or is disqualified from an individual event, must prove his/her time, i.e., must provide documentation that he/she has swum at least as fast as the entry qualifying standard, or pay a fine in the amount of two hundred dollars (\$200).

Non-Championship meets with qualifying times may establish other proof of time penalties or fines.

Acceptable proof of time includes the USA Swimming SWIMS database and printed or viewable Meet Final Results from any USA Swimming sanctioned, approved or observed meets, high school meets, YMCA closed competition, and NCAA closed competition. Acceptable proof of time identifies the swimmer by name, his/her time, and the meet name and the date on which the swimmer previously achieved the qualifying time. High school meets include any season ending meet (Conference, Sectional, State Championship).

The results of a Time Trial, conducted at or in conjunction with the meet for which the proof is required, is not acceptable.

A team with an unresolved proof of time must prove the time or pay the fine by the conclusion of the meet.

A team owing a proof of time penalty or an unattached swimmer owing a proof of time penalty may not enter an LSC sanctioned or approved meet until the proof of time fine is paid. The Meet Director shall inform the Sanction Coordinator about the team or unattached swimmer owing the outstanding fine and provide contact information. The Sanction Coordinator shall advise the team or the unattached swimmer regarding the fine and inability to participate in another sanctioned or approved meet.

### **CONDUCT OF THE MEET**

**Format:** The meet will be a combination of prelim/final events and timed final events. Flyover starts will be used. Swimmers will report to the blocks for prelims. Swimmers are asked to line up outside the designated area for Top Heat of Finals and will be marched behind the blocks. These procedures will be clearly explained at the coaches meeting.

**Breaks:** Breaks may be inserted and removed at the discretion of the Meet Management.

**Finals:** See Order of Events for designated heats coming back for Finals.

Designated Disability Events will be completed in a separate heat, combined by classification and gender, but separated for scoring and awards. These events will take place between the female and male sections of the corresponding event.

### **CHANGES TO THE MEET INFORMATION:**

Any changes to the meet information based on conditions that preclude a safe or effective conduct of the meet will be discussed, reviewed, and voted on at the coaches meeting held each morning before the beginning of the first session of the day. Changes must be approved by a majority vote of coaches in attendance at the appointed meeting.

### **VOLUNTEERS:**

The LSC will need the assistance of all participating clubs as timers and meet marshals to ensure the meet runs smoothly. Teams will be assigned to provide volunteers based on the number of entries into the meet. A sign-up link will be posted on the meet landing page. ***Per Wisconsin Swimming Rule 2.6.1 clubs can be assessed a fee if they do not provide volunteers.***

### **SCRATCHING AND DOWNSEEDING**

#### Scratch from Prelims:

Swimmers may scratch from an event in which they are entered by submitting a scratch form. The "scratch box" will be online for this meet. Information about the online scratch box will be communicated to coaches and available on the meet landing page.

Swimmers may scratch from an event in which they are entered by following the procedures set forth in the meet announcement.

In all events where preliminary heats are necessary or in any timed final event for which the swimmer has been positively checked in, after the heats have been seeded, any swimmer who fails to compete in an individual event heat in which such swimmer entered and has not been scratched in accordance with above will be barred from all further individual and relay events of that day.

The application of this penalty shall pertain to the order in which the event/heats are swum, not the numerical order of the events. Additionally, that swimmer shall not be seeded in any individual events on succeeding days unless that swimmer declares an intent to swim prior to the close of the scratch box for that day's events.

No penalty shall apply for failure to withdraw or compete in the Prelims or Timed Finals heat of an individual or relay event if the swimmer or coach notifies the Administrative Referee or the Deck Referee prior to the swimmer's assigned heat of a Declared False Start.

#### Scratch Deadlines:

#### Down-Seeding:

Down-seeding will only be allowed for Individual distance events (1000Y and 1650Y freestyle and 400 relays events). Down-seeding must be declared by the scratch deadline for that event. Down-seeding procedures will be announced at the general meeting.

#### Declared False Starts:

A DFS can be made by the coach or swimmer to the Administrative Referee or Deck Referee at any time prior to the start of a heat in which the swimmer is seeded, in an event for which they have checked in or failed to scratch, during the preliminary sessions. During warm-ups (prior to the start of the session), the

DFS is given to the Administrative Referee in the glass office. After the start of the session, the DFS is given to the Deck Referee.

A DFS may be made in a Timed Finals event and for swimmers in the fastest heat swimming with Finals in a Timed Finals event. No explanation for the DFS is required, and all requests shall be granted. A DFS is a disqualification for the swimmer and counts towards the total allowed events per day and per meet.

DFS is not allowed in Finals. If a swimmer fails to compete in finals (except due to injury, illness or circumstances beyond the control of the swimmer, as determined by the Meet Referee), it is a failure to compete and the swimmer is barred from the remainder of the meet.

### Relays:

A relay team member failing to appear ready to swim for the relay event shall be barred from the next individual event in which the swimmer is entered, on that day or the next meet day, whichever is first. The relay team members who do appear ready to swim shall not be penalized for failure of the other team members to appear.

### Scratching Timed Finals

Scratches, from seeded time final events with heats competed during Finals shall be made directly with the Administrative Referee.

### Events in Finals:

NOTE: After an event has been seeded, do not use the online scratch process to scratch from timed finals heats competed during Finals.

### Scratch from Finals:

After the preliminary heats from both preliminary sessions have swum, results will be announced. After announcing is complete swimmers will have thirty (30) minutes to scratch or declare their intentions to scratch. Once events close there is no scratching from finals.

### Failure to Compete:

Any swimmer qualifying for a Finals race in an individual event who fails to compete in said race shall be barred from further competition for the remainder of the meet. Disqualification under this section shall apply only to swimmers qualifying based on the original preliminary results. However, if a swimmer or coach is notified that the swimmer has scratched into a Finals race in an individual event, accepts the position, and then fails to compete, the swimmer shall be barred from further competition for the remainder of the meet.

In the event of withdrawal or barring a swimmer from competition, the Meet Referee shall fill the Consolation Final or Championship Final when possible with the next qualified swimmer(s). First and second alternates shall be announced along with the Final qualifiers. These alternates shall not be penalized if not available to compete in Finals.

When Consolation Finals have not yet been swum and a barring or withdrawal is known to the Meet Referee, the Meet Referee shall reseed the Consolation Final and Championship Final, if necessary, by inserting the alternate(s) in the appropriate lane(s), filling all lanes in the Championship Final race. If a

Consolation Final has been contested, the companion Final shall be swum without reseeding for empty lanes.

Finals Check-in procedure will be discussed at the coaches meeting.

No penalty shall apply for failure to withdraw or compete in an individual event if:

1. The Meet Referee is notified in the event of illness or injury and accepts the proof thereof.
2. Bonus, Consolation, or Championship Final based upon the results of the preliminaries notifies the referee within thirty (30) minutes after the announcement of the qualifiers for that race that they will not compete.
3. A swimmer qualifying for a Bonus, Consolation, or Championship Final race based upon the results of the preliminaries notifies the Administrative Referee within thirty (30) minutes after announcement of the qualifiers for that race that they may not intend to compete and further declares their final intentions within thirty (30) minutes following their last individual preliminary event.
4. It is determined by the Meet Referee that failure to compete is caused by circumstances beyond the control of the swimmer.

### AWARDS AND SCORING

#### Awards:

Individual Events: Medals for 1<sup>st</sup> to 8<sup>th</sup> Place. Ribbons for 9<sup>th</sup> to 16<sup>th</sup> Place

Designated Disability Events: Medals for 1<sup>st</sup> to 3<sup>rd</sup> place in each category.

Relays: Medals for 1<sup>st</sup> to 3<sup>rd</sup> Place. Ribbons for 4<sup>th</sup> to 8<sup>th</sup> Place.

Individual High Point: 1<sup>st</sup> to 3<sup>rd</sup> Place for each gender and age group.

Team Champions: The LSC will provide an award for the overall 1<sup>st</sup> place team in each of the three divisions. 2<sup>nd</sup> and 3<sup>rd</sup> place team finishers will have an opportunity to purchase awards if they wish.

State Champion T-Shirts will be available to all winners (one t-shirt per athlete).

#### Award Presentations:
