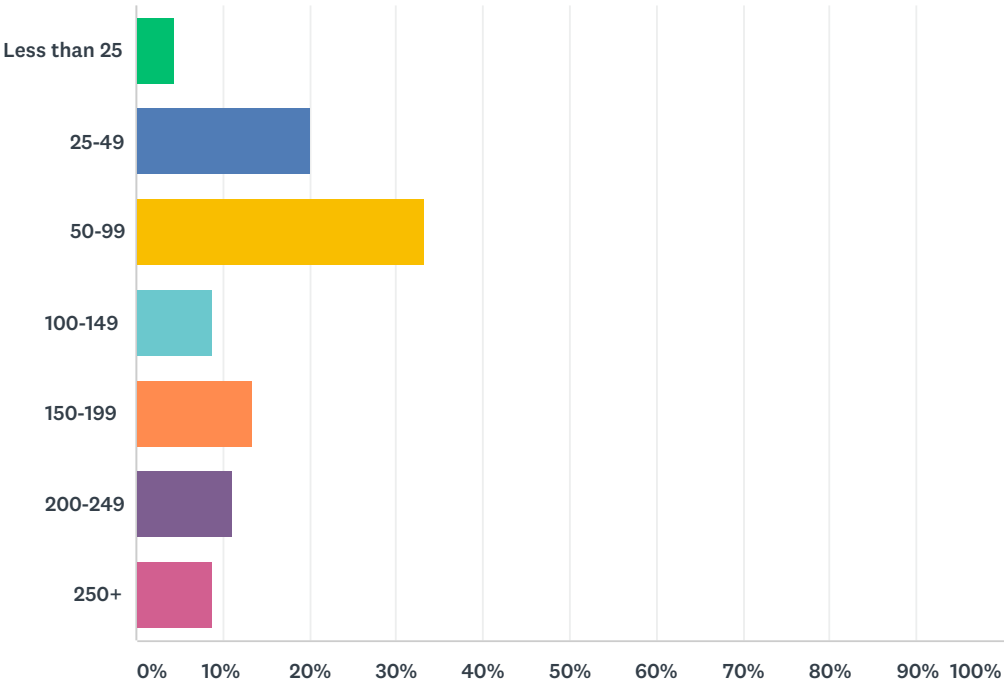


Q1 How many swimmers are active for the fall and/or winter sessions?

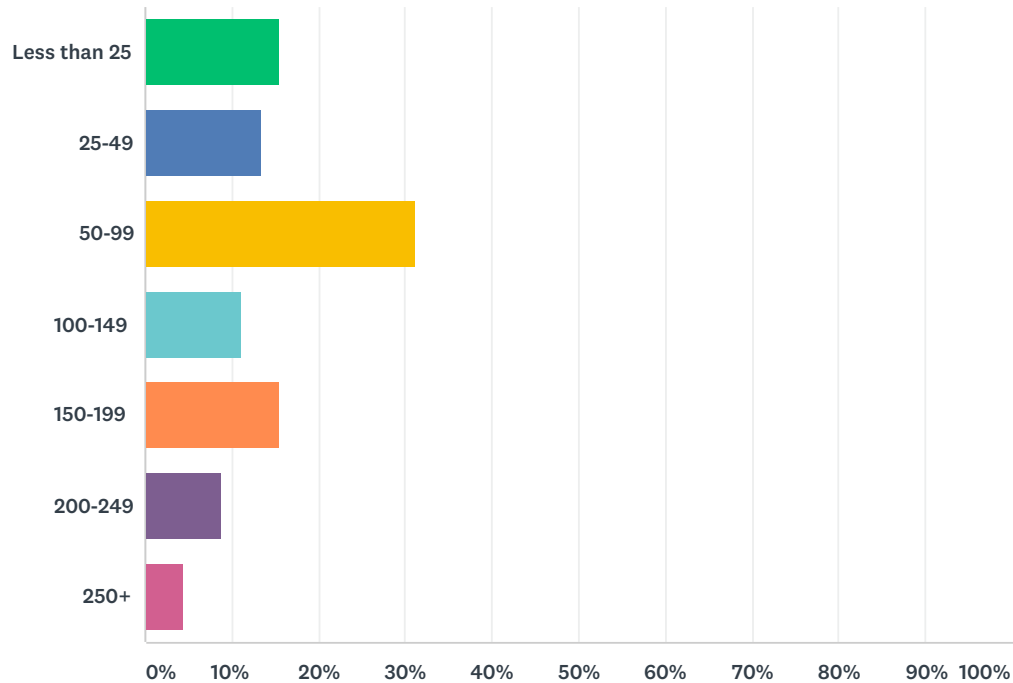

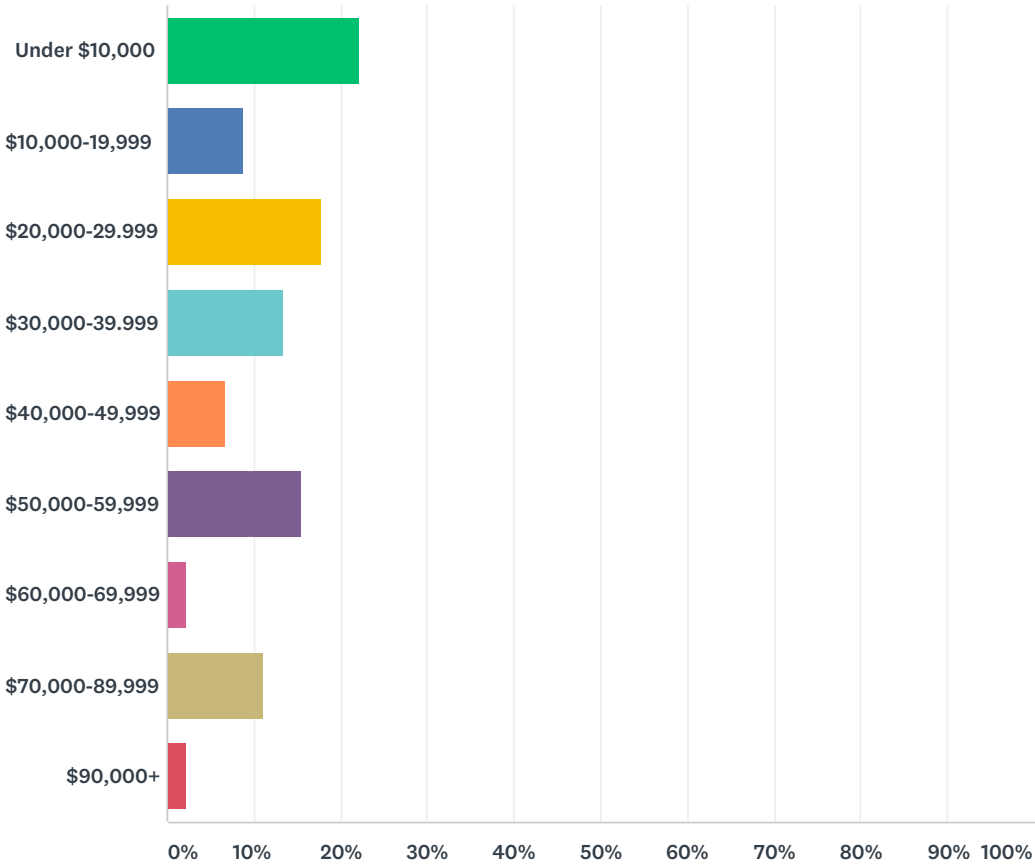

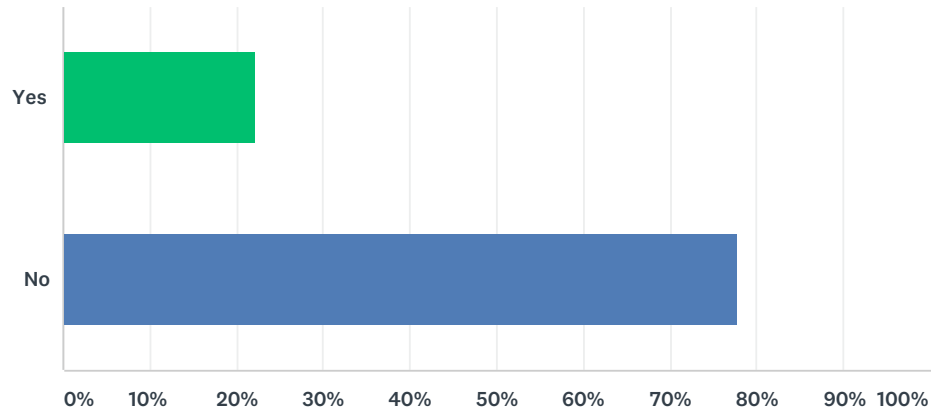

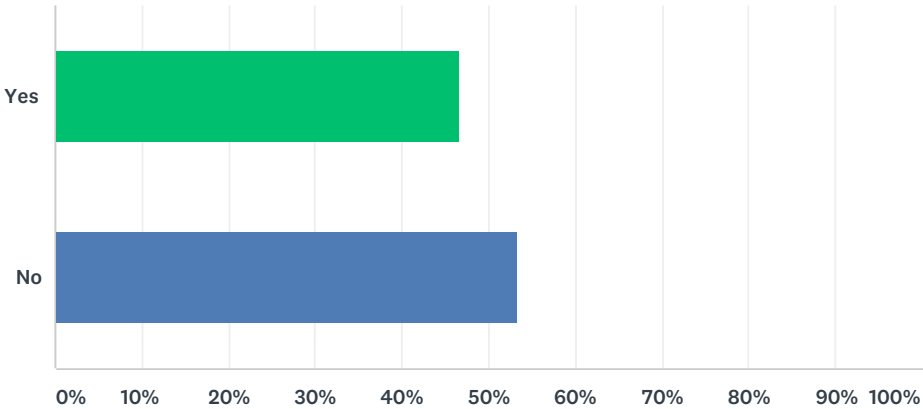

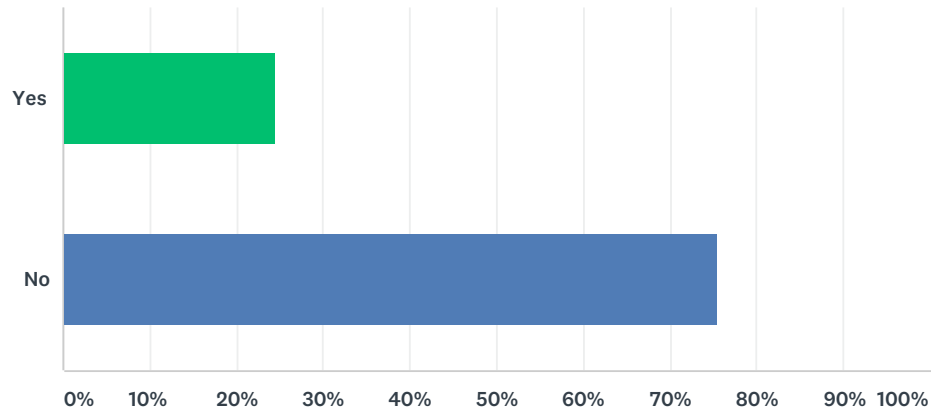

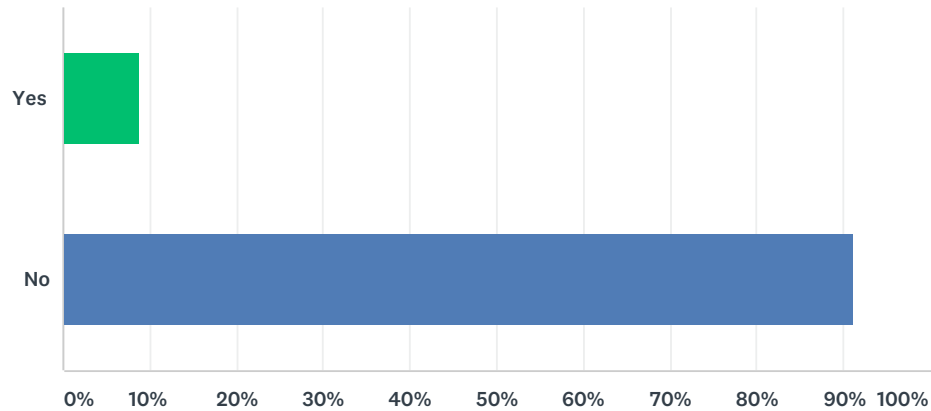

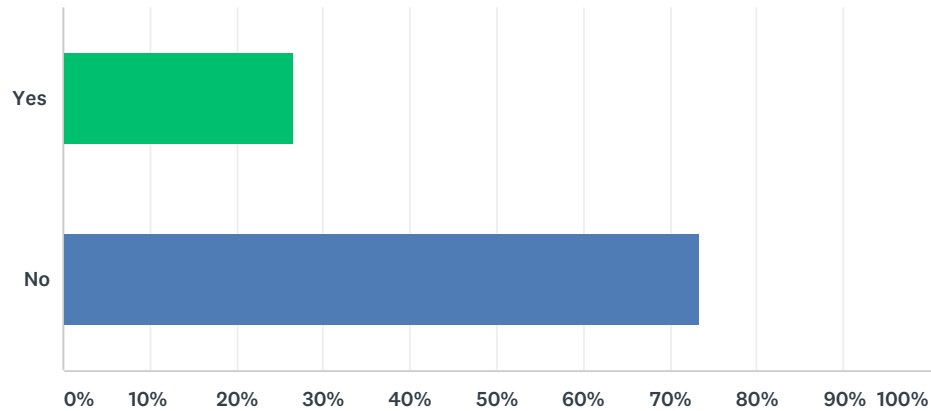

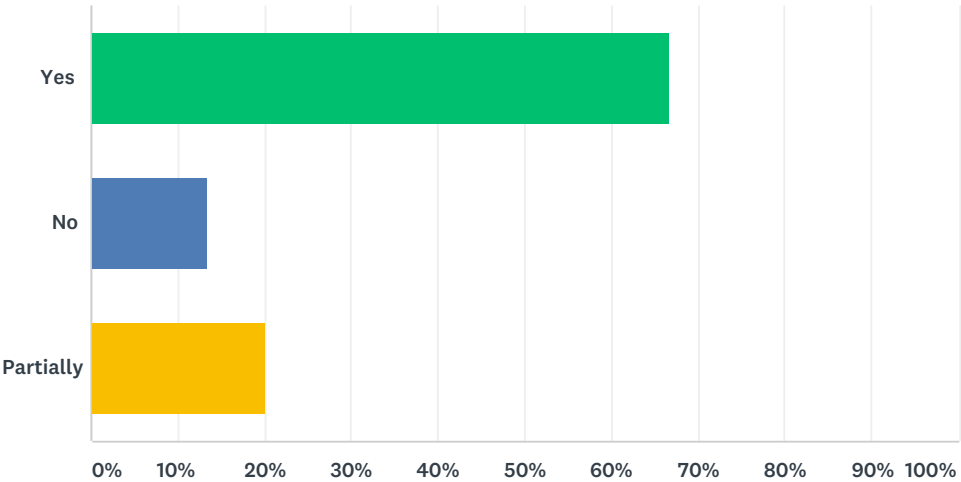

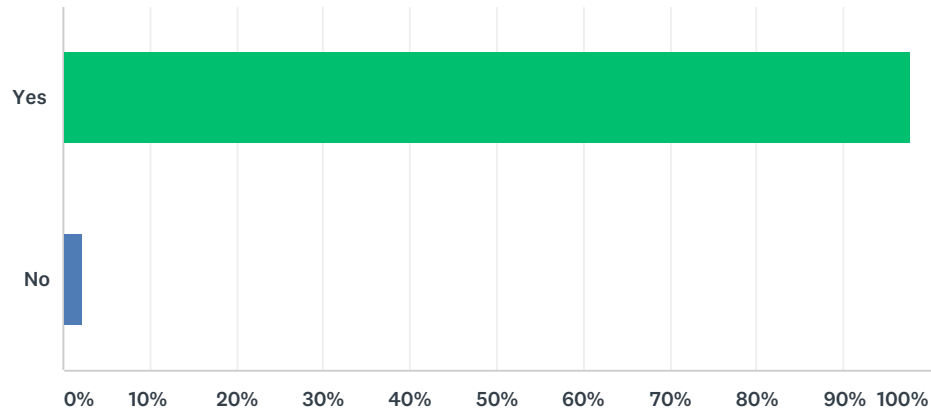

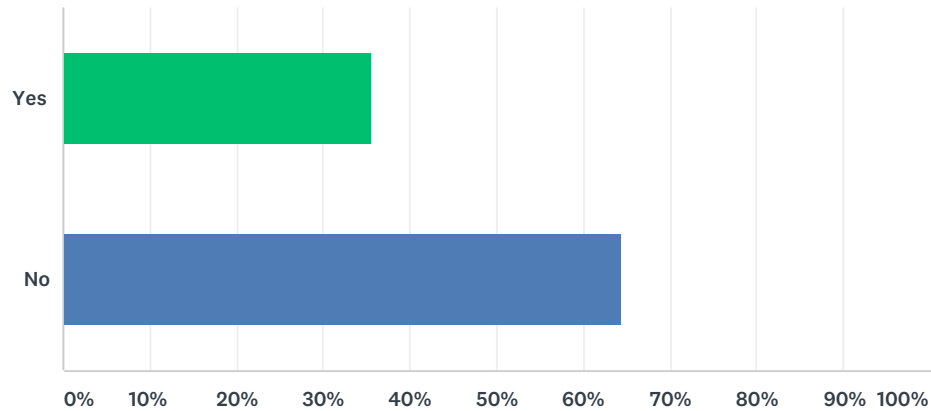

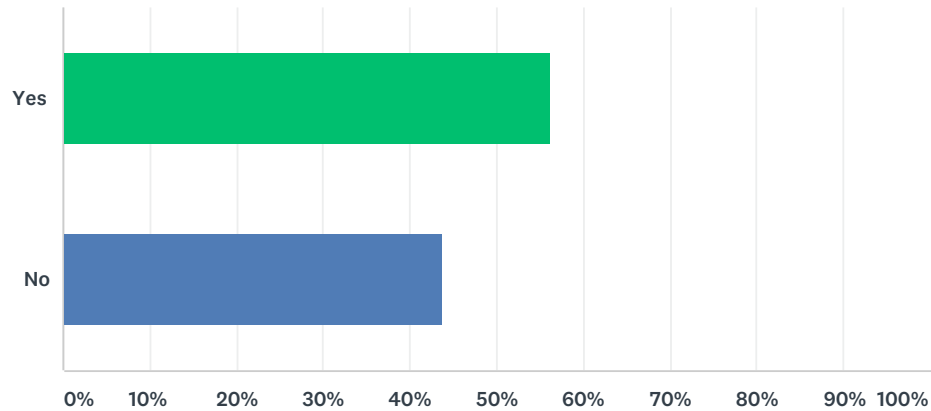

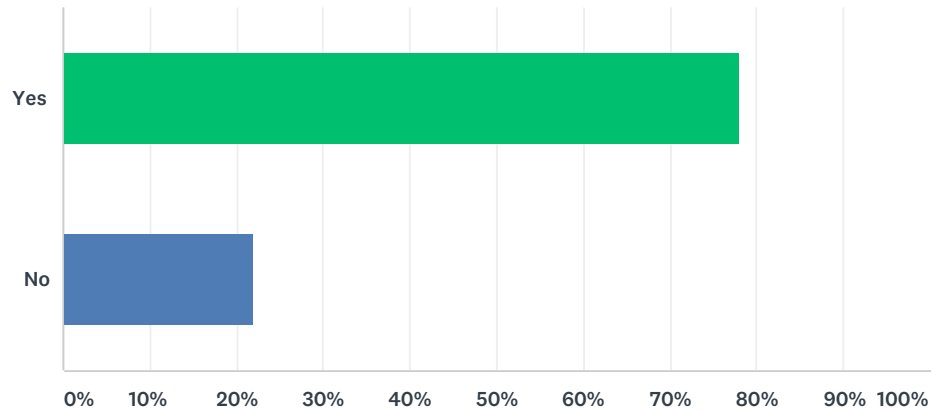

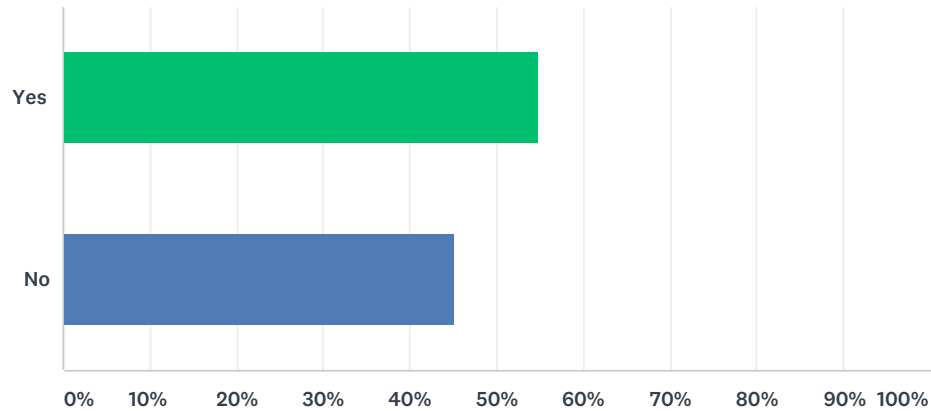
