### INTRODUCTION:

The Middle Atlantic Conflict of Interest statement read by Andrew Austria, Governance Chair

The Board of Directors in attendance were introduced by Kate Scheuer, General Chair

#### ANNOUNCEMENTS:

Kate Scheuer, General Chair, presented an overview of the LSC, emphasizing a return to normalcy and promising an emphasis going forward on athlete and coach engagement.

Jamie Platt, Executive Director, presented a "State of the LSC" address. His presentation focused on our current activity levels, including membership counts:

- 11,214 athletes
- 1.441 non-athlete members
- 118 clubs

The report indicated an increase in meets conducted since pandemic restrictions are being lifted, this includes 179 sanctioned meets to date, and 13 Championship meets (SC and LC). Middle Atlantic has been awarded the Eastern Zone Open Water Championships. He reported the purchase of an office condo by Middle Atlantic, which he referred to as a "home for our LSC." He also recognized Charlie Kennedy of Suburban Swim Club who was honored with induction into the ASCA Hall of Fame.

In terms of new programming, Platt addressed the RISE Athletes mentoring program and the four poolside chats conducted for parents. The first "Swimming in College" seminar was implemented for parents of senior swimmers and was attended by over 100 people. Also

noted were two OQM meets to provide officials with opportunities for evaluation and national advancement.

With regard to community involvement, Middle Atlantic provided sponsorship of both the Pennsylvania and Delaware state scholastic swimming championships. The New Jersey Adventure Aquarium's provided sponsorship of our Middle Atlantic 10 & Under Championship meet. Also reported was the creation of a new partnership with All Sports Travel, which will facilitate travel arrangements for individuals and clubs within the LSC.

The Middle Atlantic Conoco Phillips 66 Volunteer of the Year Award was presented to Larry Schwarz, Administrative Vice-Chair, with a testimonial from Joel Shinofeld, USA Swimming.
