 - balance sheet shows asests down \$33,000.
 - PPP not reflected as of July (add in \$34,000)
 - Of note: July, paid Grant Matches. A 2nd round is coming.

3rd quarter income statement (greatly affected by COVID)

- Smaller registration & meet fees.
- Smaller expenses- travel—none for spring or summer. No Convention travel Income is down but expenses are down as well.
- b. Budget 2020-21: In Dropbox
 - Changed athlete registration predictions from 11000 to 9500
 - Non-athletes from 1250 to 1000
 - Meet revenue from 285000 to 225000
 - Winter travel and Convention to \$0
 - Travel Committee recommends no travel this winter

 - a. Correction to Athlete Elections in Dropbox
 - Athlete election to HOD and Athlete committee determination. Posted on website within 20 day notice
- b. Revised Policy wording staff reimbursement L. Schwarz
 - Changed from just Director Competition to all staff and streamlines procedure Motion passes
- c. At-Large Delegates to House of Delegates meeting L. Schwarz
 - Bylaws allow the chair to approve 10 at large delegates

Not prohibited in our By-laws

Will require addition of athletes to HOD.(43 instead of 42).

Issues: Staff not having vote is a procedure to prevent conflict between the paid staff and the non-profit organization

Staff would vote for the board that approves salaries.

Staff as At-large Delegates is tabled.

- d. Crisis Management Team recommendation for new Board of Directors start date J. Platt The CMT made a recommendation in the spring for the new board to take offices in October. They now recommend a September 1 start date. There were no objections.
- e. Club status changes J. Platt
 - a. Staff discussed clubs need to be in good standing to be members of USAS.
 - i. Head coach in good standing at all times or status is in question.
 - 1. Athletes could be unattached and then attached \$10 fee. Seeking board support for the \$10 transfer fee imposed.
 - 2. Coach not up to date means insurance is not valid and athletes will not be covered. Will protect athletes.
 - 3. Who will pay? Club or athletes.
 - 4. Amy reach to dry side, Mike reach wet side each month to proactively let clubs know they are not in good standing.
 - 5. Asking board to support the transfer fee is proactive
- f. USAS status L. Schwarz
 - a. Sanctioning meets is at discretion of LSC. Border restriction for meets is supposed to go at the end of the month. Had cooperation from neighbors for open water swims. USAS is giving out more grant money.
 - b. Virtual convention attendees need to be sent by beginning of September.
 - Voting members to USAS before next board meeting. Awarded extra votes. GC admin,, age, sr. .coach .and sr. athlete plus 3 extra and anyone on national committee. Submitted by GC
