NJ SWIMMING DIVISIONS

NJ Swimming has moved to a consent agenda format for meetings. Division reports will be submitted prior to the meeting by each of the NJ Swimming Division Chairs: Administrative, Age Group, Finance, Senior, Athletes and Coaches. These will be passed as a block unless “pulled” for discussion. Should any member of the HOD have questions regarding any of the reports, indicate by stating “PULL” when indicated to do so.

NEW MEETING SCHEDULE: BOD/HOD

As we approach 2023, NJS will be reverting to in person meetings for Board of Director Members. We will meet 4 times annually. Per the fall HOD, the HOD will meet in the spring only moving forward per the by-laws. The body will meet each fall for our annual fall committee meetings with many committees meeting in person. The Board will review division reports, approve financials; consider upcoming proposed legislation to be presented to the HOD.

- April/May Annual (Spring) HOD Meeting – including a separate BOD Meeting
- September/October Annual Fall Committee Meetings (NEW) – the plan is to have several meetings leading up to a BOD meeting: Athletes, Coaches, Officials, Age Group, Senior, Technical, Championship Standard/Schedule, Governance, DEI, BOD

COMMITTEE RELIANCE

The LSC, HOD, BOD will rely upon our committee structure to vet and approve meet formats, championship structures, policy and procedure proposals and many other matters previously addressed by the BOD. It is critical that NJS has active functioning committees. Coaches, Athletes and Volunteers are encouraged to contact committee chairs if interested in participating.

GOVERNANCE PROCESS

Policy proposals will be due to the Governance Committee no later than February 15th each calendar year for consideration. These items will be presented at the Annual (Spring) HOD Meeting and will require either a simple majority (50%) or 2/3rd majority to pass depending upon whether policy, procedure, or bylaw changes. Any items being considered by the HOD, not submitted to the Governance Committee by February 15th, will require a 90% majority to pass. It is preferred all proposals are first vetted by committees, divisions and as necessary the BOD before being submitted to the Governance Committee. The Governance committee will determine if the proposals are in compliance with USA Swimming Rules and Regulations and have merit for consideration by the body.
