

# **ATAC Booster Meeting**

**Date:** June 11, 2025

<u>Call to Order Time</u>: The meeting began at 5:39 p.m.

### **Coaches Report:**

Coach Amanda explained that the coaches were very pleased with how well the Gainesville meet went last weekend. The swimmers did a great job, and many had best times. The summer season is off to a great start and there has been a steady amount of kids trying out for the team. She explained that the coaches are excited about the summer developmental meets. The swimmer and job sign-ups for the first two developmental meets are available on the website. The deadlines to sign-up for the summer developmental meets are the Friday before the meets on the following Tuesday. Coach Amanda also stated that the swimmer and job sign-ups for the ATAC Long Course Invitational on June 27-29 are also available on the website. This meet may even have a few international swimmers participating. Lastly, she shared that Ethan and Owen Ekk are doing a great job in Canada and both will qualify for the World Championships.

## **President Report:**

Booster President, Crystal, explained that we will need volunteers for hospitality and timers for the ATAC Long Course Invitational on June 27-29. Crystal also stated that the Treasurer position is still an available board position, and she would really like someone to become hospitality chair. Once we are into the summer season, she will send out an email about possible sponsorship for next year.

#### **Treasurer Report:**

For the month of May 2025, we generated a Total Income of \$5,814.47, incurred \$0.00 in Cost of Goods Sold and Gross Profit of \$5,814.47. Notable income during this period was from annual team fees, meet entry fees, and merchandise sales. The Boosters incurred Expenses totaling \$7,969.70. Notable expenditures during this period were for awards and prizes, license and training, facility rental, meet entry fees, and coaches travel to away meets. For the period, the Boosters generated Operating Income of (-\$2,155.23). The Boosters account has a current balance of \$33,377.57 which puts the Boosters in a sound financial position for the summer season.

## **Committee & Rep Updates:**

ATAC Spirit Gear Chair, Christina, explained that she sent emails out to parents to order



team shirts, caps, towels, pajama pants, and hats. These orders are due by June 16 at 10 a.m. She is also working on the shirt design for the ATAC Long Course Invitational at the end of June. She will send out an email to order these shirts once the company sends her the design.

# **New Business & Updates:**

Coach Amanda explained that all Age Group swimmers will need to swim up an age level or swim the open events in order to give the novice swimmers a fair chance to participate and gain confidence. Coach Amanda also suggested that ATAC gear be sold on deck at the summer developmental meets.
