- c) City report Monica / Leon: bought the blocks and they are coming in

  - City Parks Design Plan (1) few people came to planning event. (2) Advised board members to complete online survey and forward to Gator families.

- e) Treasurer's report Beau: See attachment. Raised scoreboard will not affect budget anytime soon as the board won't go up till after the next swim season.

- g) Time Drops Leon: Cost \$1,800 plus a tablet (not Amazon Fire) and wi-fi router. User friendly system with key fob where parents can see scoreboard in real time. Turn-around would be 2 weeks.
- h) Snack Bar: Per inspector refrigerator must be at or below 41 degrees, can start immediately once we have permit, \$295 per year, we don't need commercial grade equipment (recommended). One food safety person must be present at the pool during snack bar usage. Will verify approximate cost of insurance.
- i) Canopy Leon: two vendors contacted with quotes of \$1,700 and ~\$1,280. Motion for 10 by 20 JP 1<sup>st</sup> and JS 2<sup>nd</sup>, approved by 6 members. Motion for Euromax octagon poles JP 1<sup>st</sup>, KC 2<sup>nd</sup>, 6 members approved.
