**Competition Support - Gulf Swimming (GS) has over 50 member swimming clubs. GS funds swimmer travel to National level meets for swimmers from a member club. Travel expenses were paid for nearly 740 swimmers in 2022. 118 swimmers from GS attended the Southern Zone Senior Meet at a cost of \$87,100, while another \$12,130 enabled 271 swimmers to swim in the Gold Medal Clinic. \$32,400 was spent to assist the 64 swimmers who represented GS in the Futures Championship. In addition to these three events, GS used \$149,500 to fund another 168 swimmers who represented GS in 11 other National level meets.**

**Training and Education - Gulf Swimming (GS) hosts conferences for member clubs, and participates in the USA Swimming (USA-S) Annual Convention. GS held regular Gulf Swimming Swimmer Athlete and Coach Clinics, as well as training classes for those officiating at member meets. In 2022 GS held a Diversity Clinic to encourage diversity equity and inclusion.**

**Support for swimmers and clubs - In most years Gulf Swimming (GS) holds an annual banquet to honor the swimmers' achievements during the past year. The banquet was cancelled in 2022, due to continued complications due to the COVID-19 pandemic. Using their Outreach program, GS aids families with the cost of their USA Swimming membership. In 2022, 25 swimmers from 16 families qualified. During 2022 3 member swimmers were each awarded a \$2,000 scholarship. For more information on the Outreach Program and Scholarships, see Schedule I. GS also purchases timing and other meet equipment. This is rented out to support member clubs who don't have access to this equipment.**

Each year when a swimmer renews his/her USA membership, he or she can apply for the Outreach Program. Proof of income is submitted at this time. Government Income Guidelines are used to qualify each family for the Outreach Program. Once qualified, the swimmer athlete's parents apply for reimbursement for fees paid for each meet. The swimmer must be qualified to swim the event, as participation is verified for each meet and event. During 2022, 25 swimmers from 16 families, received this outreach assistance.

**Line 2 - Scholarships.** Each year Gulf Swimming awards a certain number of scholarships to its member athletes. The athlete has to apply for the scholarship by completing an application and submitting references. The Scholarship Committee reviews all applications and awards the scholarships based on academics, service to the community, and other volunteerism. In 2022, three \$2,000 scholarships were awarded.
