  - 1 2015 MIL invitational
    - At 2015 MIL invitational, MIL's AD for swimming & diving James a. Sparks purchased caps for all swimmers, with the understanding that he would be reimbursed (\$290) from the \$5/swimmer fees collected for the meet. Because there was no organization to which schools could pay the fee, MAGSA agreed to collect the money. Kamehameha parents spent just about all the reimbursement money on snacks and prizes, and James never got his reimbursement. Malcolm had Jenny reimburse James from MAGSA and offered to do a donation to MAGSA to cover the expense since the school wasn't responsible and getting reimbursement from the parents would be bigger trouble with bad feelings all around.

- 1. KAC will be open for use
- 2. Will have to measure pool and test equipment

- 5. Will be soliciting help from MAGSA teams for timing, hospitality and concessions
- D. By-Laws update

  - 2. Lane lines in 25-yd pool at KAC cracked and dangerous for swimmers could easily cause injury. About \$8000 to fix.

  - 1. June 11 meet location will be changed to Sakamoto pool if KAC not ready. Last minute decision will be made!
  - 2. June 4<sup>th</sup> is ABC meet at Pukalani pool (rescheduled meet previously set before Sakamoto Invitational meet)

  - 1. Malcolm sent out Fall schedule to MAGSA to look over. No input received thus far.
  - 2. Pentathlon will now be All-Island Virtual meet on Sat, Sept. 10<sup>th</sup>.
  - 3. ABC meet added in October.
