#### **OLD BUSINESS**

2012 Budget Discussion and passage of budget recommendation for HOD March meeting. (Peggy Glasgow, Finance Vice Chair)

- 1. The Board reviewed the proposed 2012 Budget. The Board asked that lines that are not to be deleted from the budget document. The discussion first focused on Revenues and then Expenses. There was discussion on the \$48,000 estimate, but it was agreed to accept it. The following additions were added to the expense lines:
  - a. purchase of hardware +4500 (total \$8,500)
  - b. Coaches clinic for Fall increase to \$10,000
  - c. Increase JAG at \$4,000; Senior Champs \$5,500
  - d. Board Misc. \$2,000; Board travel \$5,000
  - e. Officials uniform: \$7,000
- 2. The Treasurer will produce a document that gives a detailed description of the line items to insure continuity in what is charged to a specific line. For example: Team Hawaii:Travel Reim
- The revenue section will show a line item for transfer from the reserves to balance the budget. The Treasurer will make a final report to the HOD is March on the income and expenses for 2011, and report the current levels for all accounts.

Scheduling process (Age Group). The Board accepted the Spring and Summer schedules as posted on the website, after moving the August B/C meet to August 18. These votes were taken during the Age Group Chair's report.

## **NEW BUSINESS**

Consent Agenda: #1 and #2 were passed unanimously.

- 1. Purchase new Colorado Timing Console (approximately \$4,500.00 plus shipping)
- 2. Chair on behalf of Fred Tester (Equipment coordinator) Passed
- 3. Purchase two new computers for clerk and interface usage. (approximately \$2,000.00 each) General Chair on behalf of Fred Tester Passed

Discussion ensued on the Western Zone Workshops. We will send three persons to the workshops. The LSC covers their airfare. USA Swimming will cover their registration and hotel and some meals. The Times and OME are a single track in the workshops therefore Jon will represent us as the Senior Committee is working on introduction of OME for LSC meets.

- 4. USA Swimming Western Zone Workshops: LSC will send three individuals to the USA Swimming Zone Workshops: Registration/Membership: Gwenn Tomiyoshi; Times/OME: Jon Hayashida; Officials: Sandy Drake. (April 13-15, 2012 at JW Marriott Desert Ridge Resort and Spa, Phoenix, Arizona) General Chair on behalf of USA Swimming and Western Zone passed unanimously
- 5. General Chair will attend the WZ General Chairs Workshop on the same weekend at the same site. Passed unanimously
- 6. Oceania
  - a. USA Swimming has chosen Hawaiian Swimming to represent the US at the Oceania Games over the past decade. We have not paid anything up to now. After the events in 2010, USA Swimming discussed this commitment. Jon Hayashida spent a great deal of time developing a set of proposals so that Hawaiian Swimming could continue to participate in the meet. USA Swimming offered \$14,000 as their share of the approximate \$50,000 needed for the trip (4 men, 4 women, 2 coaches, and 1 manager). The board authorized \$36,000 to Oceania for our part of the expenses. (passed unanimously)
  - b. Jon's proposal documents will be posted with the minutes for the meeting.
  - c. The Board moved the proposed select camp to 2013 (It is supposed to occur in non-Oceania years) passed unanimously
- 7. Bylaws change: require only two meetings of HOD each year.

8. The Board accepted the meeting schedule for 2012 based on the proposed change to the By Laws.

#### 604.5 ANNUAL AND REGULAR MEETINGS

The annual meeting of the House of Delegates of Hawaiian Swimming shall be held in the month of <u>December November</u> each year or during the Hawaii State Age Group Short Course Championship, at which time the election of officers shall be held. The officers' terms shall commence on January 1. Regular meetings of the House of Delegates shall be held <u>quarterly</u> in accordance with a schedule adopted by the Board of Directors.
