**Discussion:** Question as to why the Short Course Championships will be in Kihei. Explained that next summer Long Course will be on Oahu again as Maui will be hosting Western Zones, so a swap was made. At this time, we do not know the 2015 Senior Sectional dates.

**Action Taken:** Moved that we approve the 2014 Short Course Age Group Championship be held in Kihei from December 19 – 22, 2014 and VMAC for the 2015 Long Course Age Group Championships from July 16 – 19, 2015. ***Motion approved unanimously***

## C. New Business

### 1. Kihei Swim Club (KSCM)

**Discussion:**

- They have already been approved by USA Swimming
- Need to officially accept them as a member of Hawaiian Swimming
- The only reasons to not approve a Club is if it can be shown that adding the Club would cause irreparable damage to the LSC. Cannot be based on personnel.
- Concern is that the coaches don't have any head coaching experience and may injure kids. Also, a concern is that the club may fold once their daughter graduates in a year and there will be kids left without a Club.
- Maui County has said that they don't want two swim teams practicing at the same time, so this new team will have to find open pool times.

**Action Taken:** Motion that Kihei Swim Club be accepted into Hawaiian Swimming. Motion was approved with two abstentions (one from Age Group
