- B. Kenny Chew reported that Dave Coleman wanted us to know we completed report on LEAP I and waiting to hear back.
- C. Gwenn Tomiyosh reports there is a new Athlete Protection online education requiremen. It follows from USA-S 502.6.1 per USA-S all non-athlete members need Background (BG) check AND need to take online training class (APT) which includes a test.
 - 1. Results will load directly to SWIMS queue, and will take ~1 hour to complete. Non-Athlete members must do training and take exam to pass.
 - 2. There is no fee.
 - 3. Once sucessfully completed it should be online in 1 day.
 - 4. If user logs out before passing, it won't count.
 - 5. Additional info can be found at usaswimming.org/protect. Test will be online to take after Sept 15; 2012 registrations for Non-Athlete members can't be processed without it.
 - 6. New coaches starting between Sept 1 & Sept 15 will have a problem getting registered. Existing coaches in good standing until Dec 31.

II. Reports:

A. General Chair – Not in attendance.

Schedule 2012 (also need time standards by August (M.Cooper will look at this week) can be done and approved by email). The schedule was put on overhead since not everyone had seen or brought a printout.

- i) Motion to approve schedule as presented. (Jon Hayashida, 2nd Reid Yamamoto)
 - (1) Discussion:
 - (a) Maui (M.Cooper) schedule OK. We've moved Lahaina C-schedule Oct 22 to Oct 29 to avoid Bill Smith Invitational conflict. All Fall meet notices ready for posting.
 - (b) Oahu has lots of meets in October: There are 2 Senior meets in October (Sept 30-Oct 1 and Oct 28-29); with other meets this is a problem for officials. (Sr. Chair:) The 2nd meet needs to be done 2 weeks prior to Sr. Champs in November. Earlier Sr. Meet than Sept 30-Oct 1 meet doesn't serve athletes best. (M.Cooper): Just shuffling meets doesn't resolve the lack of officials. (P.Glasgow) It's not an official's problem, it's a problem for entry people for so many meets. (M.Cooper) Entry won't change AND officials load won't change unless eliminate meets or get more officials (eg; from other islands or Sr. meet officials). (M.Arakaki) Complaint that only seeing this schedule now. She should have had it in June. Now that she sees it, it's only partial and shouldn't be accepted. (M.Cooper) what if not approved whole or in part? (Answer) No meets, so approve what we have.
 - (2) Friendly amendment proposed after more discussion ... move Sr. meet Sept 30-1 to either Fri-Sat or Sat-Sun Sept 10th weekend.
 - (a) Amendment Discussion:
 - (i) Leave to AG chair to find another date for Pentathlon: maybe either Sept 30 (probably) or Sept 17th. (P.Glasgow or M.Arakaki ... can't remember who): Maybe move to March when no meets. Why aren't there meets in March (suggested answers from multiple people conflict with pool time at UH and VMAC and elsewhere with girls water polo; also goes with move of LCM AG champs to July.)
 - (ii) (K.Chew) One purpose of Pentathlon is Q for Al Minn Invitational. (P.Glasgow) but OK since will accept entries 1 week ahead of meet.
 - (iii) (M.Cooper) Pentathlon (like on Maui) purpose is a warm-up meet; don't want big distance or Senior meet so early. (P.Glasgow) No, Maui meet was last season ... season starts Sept 1 & Maui meet in August. (M.Cooper) Not for our schools and athletes.

- (iv) Dates selected may not be available. K.Chew and M.Cooper suspect there are conflicts with pool availability if trying to move meets. So Amendment to Friendly amendment: Move meets subject to pool availability.
- (v) Call for question (friendly amendment with qualifer).
- (b) Approve 6, against 1. abstain 2. Passes.
- (3) (J.Hayashida) Would like to (motion to) add an LCM time trial meet (since this is an Olympic year) after JAG's (Feb 25-26)
 - (a) Discussion:
 - (i) Entry due dates for Olympics vs sectionals. Sectional Qualfying opportunities ... Olympics requires actual LCM time, sectionals allow converted times. (M.Cooper): could have after HS States on Maui ... did before ... dismissed because of non-HS swimmers. (P.Glasgow/MArakaki): Could have after Feb 18-19 classified meets since LCM, while JAG's are SCY.
 - (ii) Restate motion Jon: motion to have Sr. time trial after JAG's if not available for after Feb 18-19 classified meets (SC vs LC).
 - (b) Yes unanimous.

- (5) (J.Hayashida) Note: ALL Senior meets (Fall/Winter/Spring) will be Long Course this schedule.
