# b. JAG Host Reimbursement - See attached JAG Host Reimbursement Proposal

- A request was made to approve a one time reimbursement of \$1,410.36 to Splash Aquatics for compensation of meals for coaches, timers and officials.
- Splash was given \$500/day for hospitality expenses. (\$1,000 total)
- Splash was told they must use the VMAC vendor for lunches at a cost \$5 per lunch. \$2,410.36 was spent on lunches and hospitality.
- An outside T-shirt vendor was denied last minute. This revenue was expected
  to be \$2000+. Outside vendors are not allowed. However, outside lunches
  may be brought in, but cannot be similar to what is offered on site. Event
  specific items may be sold as long as it does not benefit the vendor more
  than the organization. Splash was not told this information.

Action Taken: Motion was made to approve reimbursement of lunch expenses in the mount of \$1,410.36 to Splash Aquatics. Moved and seconded. Approved unanimously.

Action Needed: Joe will write a proposal for lunch expenses for host teams. Joe will send a copy of the concession requirements to the Board.

• Future meet directors should review the concession application and meet with Ingrid to clarify information when planning their meets.

# b. 2016-2017 Meet Schedule

- All but 3 meets have been assigned for the 2016/2017 primary schedule. All teams that bid for meets got either their 1st or 2nd choice.
- KSC will be hosting the 2016 December State Championship Meet.
- HSC and KSC have requested to add their meets to the schedule, the Hawaii Invitational and the Oahu Grand Prix respectively.
- HHSAA Championship is Feb 3-4, 2017. The meet moved up 2 weeks. The change was to avoid overlap with water polo. The Age Group committee will review the schedule to see if any changes should be made.
- Dates for league championships are not known yet. The Times Administrator requested these dates to put in the application for observed meets.

# a. Jr. Representative Voting Process- See attached Athlete Representative Selection Proposal

- A proposal was submitted to change the voting process for the Jr. Rep
  position. The proposal would give a certain number of votes to teams based
  on the size of the club. The rationale is that most swimmers are not currently
  voting and this may give better representation to clubs. This would require a
  By-Law change.
- Investigation needs to be done based on what is allowed per USA guidelines.
  The timeline for this change would be to have a complete proposal ready to
  vote on at the November HOD meeting. The details of how teams can use
  their votes needs to be clarified.
- Currently less than 20% of athletes participate in Jr. Rep voting.
- There is currently no way for nominated athletes to campaign and get their information out to swimmers prior to the vote.

encouraged to get smart phones if they don't already have one. Another
option is to print the card from their laptop or tablet.

# a. Junior Pan Pacific Championships

- A document was presented showing financial planning for the endowment.
   Projections with an investment of \$24,000 per year, earning 4% would reach our goal quicker. USA Swimming's endowment earns approximately 6-8%.
- Better to invest monthly as to one lump sum annually to avoid market fluctuations. Once fully funded at \$1,000,000, we should be able to draw \$40,000 per year.
- Currently \$15,000 per year is allotted for investment into the travel fund.
  This amount may need to be increased if the Board wants to be fully funded
  quicker. Documents will be prepared and presented at the August Board
  meeting.

Action needed: Dave will have a report and the documents for the Travel Endowment ready for review by the Board at the August Board Meeting.

# Request for March 2016 JAG host additional LSC reimbursement

# **Request:**

Approve reimbursement of lunch expenses in the amount of \$1,410.36 to Splash Aquatics. This is in addition to the standard \$500 per day LSC championship meet reimbursement.

# Rational:

Unexpectedly, during the week prior, the C&C denied the request to sell custom T-shirts on-site during the meet. Expected net profits for the host team for this line item was estimated at \$2,000. This unexpected denial was NOT the fault of the host team. The host team's profit, WITHOUT the additional reimbursement was \$259.

- Budgeted: \$8,000 - Actual: \$11,298

- Surplus over budget: \$3,298

#### Implicit/Unconscious bias

We cannot change biases until we know what they are.

Bias is activated automatically (without intent), quickly and effortlessly, most times not aware of activation nor impact.

Often based on stereotypes.

Understand that we all have biases. We need to work to include others and break down biases that we have. It's never ending. Continue to work to build a diverse and inclusive sport. Be aware of what we are saying, doing, treating others. Whether it be color, race, sexual preference, etc the biases that we hold affect our actions, speech, decisions because of this unconscious bias.

Currently meet marshals don't need a background check, and on manual it is asked of them to walk in locker room to check out bullying, cell phone camera usage..etc....recommend a usa swimming member to check as they should be aware of safe sport rules.

Idea\*-bagtags for age group states promoting safe sport-recommend a budget for products to raise awareness on safesport.

#1 objective-increase awareness training examples-steal from website, show videos and talk about scenarios

#2 meet in person with a coach from every club...spread awareness on safe sport and hope it trickles down

#3 overload with information on LSC website....once every 2-3 months send out applicable articles and scenarios

Athlete Representative Selection (V. Zukeran) - Bylaw change

Proposal: In the simplest form, my proposal would be to change the "all athletes can vote" system to a system where each individual team will get an amount of votes based on the size of their team. For example, teams with 0-50 swimmers would get one vote. Teams with 51-100 swimmers would get two votes. Teams with 101-150 swimmers would get three votes. And so on.

Rationale: The athlete rep voting system is how it is because it "should be based on the voices of the athletes." However, after having watched and been in the voting process myself, I've noticed many athletes do not vote (especially if they are uninterested, do not know who is running, their friend(s) is/are not running, etc.) while athletes who do vote are those who have friend(s) who are running or know the nominees. I have also had feedback from one swimmer in particular who should have run the same year as me but had decided against it because of the voting system (the way the athletes vote and the fairness in the voting system). Also, because the voting is done at States, even more athletes are left out if they do not qualify for States or choose not to go.

A voting system like the one I'm proposing may not necessarily rely on the athletes to choose their next junior reps. But it seems to me to be a more "fair, across the board" type of voting. It would give all the nominees an even chance at becoming junior reps and it's possible more swimmers will try run for the title.
