#### a. Water Temperature

- Water temperature at VMAC was between 85-89 degrees during the 1500m at the Long Course Age Group Championship Meet. USA rules state water temperature should not rise above 82.4. Question as to whether insurance would cover swimmers if the temperature is against USA rules.
- Water temperature must be fixed. Something more permanent can be installed. Water cannons need to be run at night. Dean is talking with Ingrid to see if this is possible. Another option would be to use another pool.

### b. Equipment

- The LSC's timing console at VMAC is acting up. Repair is about \$2,000.
- Joe and Dean are doing an inventory of equipment i.e. pads, harnesses, mics. Equipment needs to be tested. Broken equipment should be thrown away.

#### **D. New Business**

## 1. Proposal to increase hospitality reimbursement

 A proposal was presented to increase the amount of hospitality reimbursement to \$750/day for selected meets (see proposal within attached Age-Group Vice-Chair Report).

Action Taken: *Motion made to approve the proposal. Moved and seconded.* 

- Currently the policy is \$500/day. The amount was already raised from \$250.
   Question as to why the proposal is for JAGS to receive the same reimbursement when it's only 2 sessions in 2 days vs Age Group Championships which is 7 sessions in 4 days. JAGS is a large meet and lunch is provided.
- Currently, clubs are allowed to submit a request to the LSC for additional reimbursement if they are over costs. These requests are reviewed by the Board. Receipts are required to receive any funds. The wording for current policy can be found in the meet contract. Suggestion to review current language to see if the policy needs to be updated.

Action Taken: Motion was withdrawn.

Action Needed: Joe will research the current language and re-submit the proposal if necessary.

#### 2. Time Standards

Action Taken: Motion was made to approve the 2016-2017 Age Group Time Standards. Moved and seconded.

- The changes were reviewed. the 15-16 and 17-18 time standards are now the same. Other times were updated using the current format, average of top 28 in the last 4 years.
- No changes to the 2016-2017 Senior time standards.

## 4. Record Keeping

- A concern was raised by Jialin Sun that a swimmer has gone unrecognized when achieving Hawaiian Records in both individual and relay events. The swimmer is a member of Sunshine Aquatics, Hawaiian Swimming and USA Swimming. The swimmer is not a US citizen.
- Nationally, other programs have foreign athletes that hold certain records.
   There is no specific policy for this. Hawaiian Swimming follows USA
   Swimming's rules. USA Swimming states that foreign athletes cannot hold national records.
- Several records have been broken by foreign athletes in the past that have gone unrecognized. If this swimmer is recognized, the data should be looked through to find other records that need to be updated.

Action needed: An ad hoc committee of NTV, an athlete rep, Admin Chair, and others will meet to review the policy.

#### E. Announcements:

- 1. Bill Krumm will be visiting. Teams interested in a visit should contact him.
- 2. A swimposium is scheduled for next year. The venue should be determined. This event should take place in the spring. Classroom space is preferred when selecting the venue. The type of speakers desired should be decided.

## Action Needed: Dustin will work on planning the swimposium.

- 3. Board members will be attending Convention in September.
- 4. Lynne continues to act as Assistant Treasurer. She will be registered with USA Swimming and remain as meet fee collector on meet notices for senior meets during short course season.
- 5. The next BOD meeting was changed to 10/2/16 due to a conflict with a meet.
