A. Approval of Minutes:

<u>Action Needed</u>: These HOD Athlete Reps will be posted on the website and have been appointed to attend the April meeting. <u>Senior Athlete</u> <u>Representative</u> will send the names to the General Chair and to the Secretary.

<u>Action Needed</u>: By the summer, an election should be held to elect the 4 athlete reps to serve on the Board and the Athlete HOD reps can be put on a slate.

Discussion: Can the athlete reps still be on the Board if they have already graduated? Do they have to be in Hawaii? It is up to the athletes to elect whoever they choose. It may be better if they were in Hawaii, but it is up to the athletes. The athletes may want to also consider UH swimmers. If an athlete wants to serve and they are on the mainland, as long as they can figure out a way to communicate and carry out their duties it is up to the athletes to elect whoever they wish.

2. Crisis Management Plan

3. Nomination Committee

Informational: No new names for the Committee at this point.

<u>Action Needed</u>: If there are any suggestions for people to serve on the Committee forward the names to the <u>Administrative Vice Chair</u>. Hope to be able to present the Committee to the HOD in April for confirmation.

4. Review of document "What the LSC Does"

Informational: General Chair did not receive any suggested changes. Would like to post it on the website to let people know what the LSC does, but will present it first to the HOD.

5. Update on Membership Numbers to consider for Athlete Representation

Informational: Technical Chair sent an email of 2013 Competitive Athlete Count. Big Island sent some corrections to the Technical Chair.

Discussion:

- The Athlete Rep shared that when they developed their list of suggested representatives, they were trying to get people from as many different teams as possible involved.
- Agree that this may be the best as it encourages people to get involved and participating. If you set a specific number from each island, what if no one wants to serve? How can you force someone to serve just to follow the bylaws?

- Suggestion that there be a "suggestion" in the bylaws to try to include a diverse group of representatives from different clubs and islands. After the election, the Board could look at the representatives and could try to balance it with an "at large" representatives if needed.
- Current athlete representatives will be extended another year and will be considered the "senior" reps and the newly elected reps will be the "junior" reps to serve for the next two years.

Action Needed: If there are any suggestions on the wording for the change in the bylaws in regards to the number of athlete representatives, please let the General Chair know. General Chair will then send out a proposed change to the Board via e-mail and the vote will be conducted via e-mail by March 10, 2014 so that it can be presented to the HOD in April.

6. Western Zone Deadlines and Team Selection Criteria

Informational: Still working on it in Committee

7. Updated Meet Schedule

Informational: Still working on it as the DOE school schedule just came out this week. There will be some changes to the schedule with the Western Zones being on Maui as we don't want to have Long Course Age Group Championships two weeks before Zones. So will discuss with the Age Group Committee about possibly having the next 3 Long Course Championships on Oahu.

8. Upcoming and Future Age Group Championship Format

Informational: Looking at possibly doing a 4-day meet, similar to the Western Age Group Zones schedule. Looking at starting earlier on the first day and adding the 800 Free Relay. In order to keep a schedule that includes enough rest time, looking at possibly using 10 lanes for prelims when at VMAC or reducing the maximum number of event entries per athlete to 6 or 7 or tightening up time standards with bonus events.

Action Needed: Age Group Chair will try to get the documents on Western Zones, Updated Meet Schedule, and Championship Format posted on the website as "drafts" at least 20 days prior to the HOD meeting to provide people an opportunity to review it prior to the meeting.

9. Committee Meetings

Informational: Committee Chairs are reminded to post their committee meeting dates, agenda, and format (if it will be via e-mail, phone, at a physical location, etc.) to allow people an opportunity to provide input. Also, Committees should post meeting minutes. March is set aside for Committee Meetings.

Action Needed: By March 1st, Committee Chairs if you are having a meeting, post a meeting agenda. If you don't have the ability to post onto the website, send it to the General Chair, Administrative Vice Chair, Technical Planning Chair or Age Group Chair and they can post it on the website.

10. LSC Quadrennial Plan (LEAP Two)

Informational: Treasurer and General Chair still in the process of working on a Quadrennial Budget. Technical Planning Chair e-mailed a Quadrennial Schedule and just need to tie in the Budget to the Schedule for the Quadrennial Plan.

<u>Action Needed</u>: <u>Treasurer</u> and <u>General Chair</u> will work on a draft of the Quadrennial Budget & Plan for the HOD in April.

11. LSC Equipment Storage on Oahu

Informational: Have been given permission to store equipment at VMAC, but will need to provide a container. Currently have been given permission to put the container on the deck in the back near the current storage area. The area can fit a container around 8' by 8'. That might not be big enough as the pads are 9 feet. Will probably need at least a 10 foot container. It appears that the Fred

Tester, who is currently storing the equipment at his house, uses an area about 10' by 10'. Is it possible to have a larger storage unit placed outside of the gate?

<u>Action Needed</u>: By summer (or earlier if possible) need to figure out a plan for storing the equipment and get it moved from Fred's house. If not at the pool, then to a temporary location. <u>Technical Planning Chair</u> should figure out how much space is needed and what the options are.

12. Job Description for possible LSC Staff person

Informational: Nothing further has been worked on at this point.

13. Oceania Championships

Informational: Sr. Committee Chair passed out previous selection procedures and the 2014 Order of Events. Will be posted on the website.

14. Western Senior Zones

Action: Proposal made by the Senior Committee Chair to establish a Team Hawaii to compete at the Western Zone Senior Championships (WZSR).

Discussion:

- Put in the proposal that teams may continue to attend the WZSR, but wouldn't be eligible for the partial travel reimbursements. This is to encourage swimmers to attend WZSR as part of Team Hawaii. It would be difficult to financially support both Team Hawaii and individual teams going.
- The "all star" concept is used by other smaller states who may not have large enough teams to send to the WZSR or even if they had a large team, they may not be competitive in the relays. The all star team would allow for more competitive relays and a more competitive team overall.
- However we choose to do it, as long as you notify people ahead of time, it should be fine. But people should know up front that they will or will not be reimbursed if they go with their own individual team.

- Proposal suggests 12 males and 12 females (24 swimmers total). If there are more than that, may need to add on additional staff (coaches and chaperones).
- If this proposal is passed, will need to change the reimbursement form.
- Should get coaches' feedback to see if there is interest. If there is no interest and most teams just want to go on their own, then maybe we should not pursue this proposal because you won't be able to get the athletes to participate.
- Also get feedback from the coaches on the number of athletes to be selected for Team Hawaii. Is 24 reasonable or should it be larger (36)? Need to consider that the timing is at the start of the DOE school year, so some athletes may not be able/willing to go. But also want to make sure that we include enough eligible athletes that want to go so that those who don't make Senior Sectionals will have a season-ending meet.
- Also included in the budget is MedEx insurance which should be considered for any LSC travel as it covers transportation back to Hawaii after any catastrophe (i.e. air ambulance). Minimal cost (\$3/day). Suggestion from USA Swimming.

Action Needed: Will send out the proposal to the coaches and get feedback. If most agree (or don't respond), will be sent out to the Board via e-mail to vote for approval along with the Bylaws change for the number of Athlete Representatives. The <u>General Chair</u> will send this e-mail vote to the Board by <u>March 10, 2014</u> so that the e-mail vote can be taken and, if passed, can be presented to the HOD in April.

D. New Business

1. Proposed 2014 Budget presented

Discussion:

- Question as to why the proposed revenues going down when the number of swimmers has been increasing. Agreed that the revenue estimate should be increased, especially since SCY and LCM Championships will be on Oahu. Increased AG LCM Championships be increased to \$15,000 and AG SCY increased to \$16,500. Meet surcharge increased Meet Surcharge to \$45,000 and Facility Surcharge (Oahu Age Group) increased to \$10,000 (and also increase Facility Surcharge Expenses to \$10,000).
- Senior Meet Expense budget increased to \$5000 because facility rental will be more since it will return to UH and will be 1 ½ days (last year it was 1 day at VMAC)
- Meet Equipment Expenses increased to \$4000 to account for maintenance and storage.
- Ribbons budget will remain the same since there are ribbons on hand.
- Increase the Interisland Travel for LSC Board Members to \$8500 to account for the additional neighbor island athlete reps.
- Senior LCM Championships had a digit missing as it was listed at \$740.
 Agreed to increase both the LCM & SCY Sr Championships \$7500.
- If someone comes in because it is a National Qualifying meet, whose budget does it come out of? If it is coming out of the Sr Meet or AG Championship budget, the chairs need to know ahead of time so it can be budgeted. Will discuss this further with the Officials Chair to see where in the budget it should go.
- Age Group Championships seem to be more expensive on Oahu than on the neighbor islands. This is because on Oahu if there is no host, the LSC has to pay for additional expenses, but keeps the revenues while on the neighbor islands, there are hosts who pay for some of the expenses and then keep some of the revenue.
- Agreed to increase both the AG LCM and SCY Championships to \$13,000 each (total of \$26,000) since in 2012 when both championships were on Oahu, the actual expenses were around \$25,000 for the two championships.
- Question as to why the revenue for Other Hosted Meets is projected to go down this year. This is because this year all of the Oahu Meets will be hosted (last year the LSC had to run about ¾ of the meets).

Action: Motion to approve the proposed 2014 budget as amended. Motion passed unanimously.

Action Needed: <u>Treasurer</u> will put in all the changes and re-check the numbers and will send the revised draft to the Board to review prior to the HOD meeting. If there are any additional changes or corrections, let the <u>Treasurer or General Chair</u> know and amendments can be made. By the middle of March, the proposed 2014 budget should be posted for the HOD Delegates to review prior to the meeting.
