III. Administrative Reports

- A. Secretary Minutes – January 2021 minutes in google doc-no discussion- APPROVED

- B. Finance Vice Chair – Report in google docs. The budget is revised. USA Swimming said we could have 2 in the works. Because registration is down, it will affect the meet income. There will be a \$4000 bill for audit from USA Swimming. Mike suggests we cut down expenses by possibly doing the coaches clinic via Zoom. He also suggests limiting the number of people attending convention. Sandy reported that since convention will be only a few days instead of the week, that will help with hotel expenses. Mike didn't realize and said yes, that will help. No athlete reimbursements have been changed. Mike appealed to USA Swimming regarding a fine of \$2100. The IRS approved that there was no penalty as we did file in time.
- C. Senior Vice Chair – No report
- D. Age Group Vice Chair (Sanction Requests) – Reid apologized for not posting the SKA age group meet. He thought it was an inter-squad meet. Kauai has requested another meet in April. Joe Glenn also requested a sanction. Jon said that we are going to require the meet host to contact their respective county to get a written approval to hold a swim meet. This will make sure HISI is abiding by the county rules without having any negative repercussion. Jon

- suggested when a sanction request comes in, we need to make sure all protocols are being followed. The sanction will be approved pending approval from the respective county.

 - F. Safe Sport Chair – Maui Dolphins Swim Club has become Safe Sport recognized. Each island needs to have a specific Safe Sport chair.
 - G. DEI Chair - We need a DEI athlete representative which they do not have to be on the BOD.
