- C. Athlete Representatives
  - Working on getting a list of people to be a part of the Athlete Committee which they will have at the next BOD meeting.
  - USA Swimming contacted them about applying for a grant to have a local leadership summit with an elite athlete attending. Senior athletes felt they shouldn't do it and asked the Junior Reps. Deadline has passed. They will continue to work on this for the future.

- Morgan Weinberg sent a save the date August 14-16. It's a group called We Lead which is Women's Leadership Summit. On the 15th, there will be an athlete specific summit.
- D. At-Large Maui Representatives -
  - HHSAA Champs is being planned.
  - Parks & Permits is giving MAGSA an extreme difficult time. They have shut down Age group diving, water polo, and Masters swimming. They had shut down MAGSA from swimming in any of the pools for four days.
- E. At-Large Hawaii Island Representatives -
  - It has been told that it will be \$4 million to repair the Kona pool.

## V. Old Business: By-laws -

- Motion to approve By-laws that are on the website. Approved.
- Changes that have been made: Athlete Reps USA Swimming would not allow us to have 2 senior and 2 junior reps. Proposing to have a Senior and Junior Rep as well as At-Large reps from each of the islands as a combination of the regions and islands. It was suggested to have a Vice-Senior and Vice-Junior Reps. The Athlete committee will come up with a plan to put people into the positions.
- Limiting number of consecutive terms for the Coach Rep which we are doing automatically.
- BY-LAWS approved as presented.

#### VI. New Business:

- Looking into policies & procedures, we need to do the scheduling of meets.
- Planning on doing a skeleton of meets where the championship meets will be on it and the different leagues (BIS, OSL, MAGSA, KAUAI) fill in their own meets.
- Policies & Procedures introduction to changes and wanting feedback.
- Changed mission statement
- Does the Athlete Protection policy need to be written out or can we just reference USA Swimming?
- Same with Best Practices and Bullying policies.
   Swimming out of class must notify NTV of any violations other than Flex.
- If Flex does have a 3rd meet, fine will be imposed if not registered for annual registration before 30 days have passed.
- Allows sanction chair to designate the ability to approve and post sanctioned events to other LSC members.
   Things that are required to be in a meet notice.
- Club sponsorship requirements leaving it to regions to state how what the obligations to host meets for each club.
- Age Group Program Meet Schedule setting a date of having the meet schedule done by the end of March.
- Senior Meets also by the end of March.
- Up to leagues if they want to host multiple meets on the same day of each island.

- Age Group Committee to establish a procedure to host invitationals
- Time standards getting them out by August 15th and approval by August 30th.
- Chaperones for Zones minimum number of 2 chaperones with additional chaperones for at least 1 chaperone for every 12 athletes.
- Scoring will be subject to meet announcement.
- Adding into the official's quota, an incentive for officials who go above and beyond the minimum requirements would count as 2 officials.
- Need wording for Section 16.03.14 Failure to Comply RE: official's quota not met. Finding a way without fining is an objective.
