- I. Meeting Called to Order – 9:33am
 - A. Introductions – None

- II. Administrative Reports
 - A. Secretary Minutes – tabled to approve until next BOD meeting
 - B. Treasurer Report – Report in google docs. There is a requirement from USA Swimming to have a CPA review all accounting. Deb is still waiting for the bill for those services. Endowment funds are reaching the max figure and we may need to reapportion the funds. Dave suggests we look at this later this year.
