Meeting Called to Order – 9:33am

- A. Introductions – None
- B. Announcements – Eric thanked Jon for his leadership for the last 4 years. Dave Coleman resigned as Governance Chair. Eric has appointed Jon Hayashida to replace Dave.

I. Administrative Reports

- A. Secretary Minutes – October minutes in google folder. Minutes APPROVED.
- B. Treasurer Report – Reports are in the google folder. Deb finished everything in December. She said there were some late deposits so it appears to be high. For the year, we grossed ~\$101,000.
