Online Registration (2023) Letter from USA Swimming came out regarding the online registration. It was presented with 2 options on how we want to do online registrations. Option 1 is where USA Swimming will collect all the monies, but there will be a 4% charge to each club. The athlete can register that morning and swim that same day. Option 2 is similar to what we're doing now. The swimmer cannot swim in a meet until after payment has been received and registration approved by the Registrar.

Jon will send out the letter to the Board requesting questions regarding the options. Gwenn needs to notify USA Swimming by August 1<sup>st</sup>. HISI BOD will most likely have a special meeting in June since we don't have a quorum to decide the direction we want to go.

Malcolm said for meet sanctions, the meet requests need to be uploaded into SWIMS by the person requesting sanction. Then it will be sanctioned once it's approved prior to the start of the meet.
