Meeting Called to Order – 9:35am

- A. Introductions – Thanks to our new Athlete Reps joining
- B. Announcements – none

I. Administrative Reports

- A. Secretary Minutes – in google docs. Discussion on the Western Zone expenses. There was question about the details from Western Zones. Deb broke it down and the report is in google docs. Jon said the LSC should cover the coaches and chaperones expenses. We were over \$23k which does not include the \$300 reimbursement to the families. Dave suggested we break it down more to what exactly the expense was for each athlete and then decide whether the \$300 reimbursements. Reid feels there should be a deadline on qualifying for the meet so all the arrangements can be made ahead of time. If someone qualifies after the deadline, the family should be the ones to make their own flight arrangements. Jon and Reid will get together with Deb to go over the details.
August minutes were APPROVED.
- B. Treasurer Report – in google docs. Our tax return is delayed. She has informed USA Swimming. Deb needs a budget for 2021. Dave has one and will send to Deb. She is waiting for the remaining Swimposium expenses. Sandy will be sending Maui's reimbursements.
- C. Registration/Membership – Gwenn is off island.
- D. National Times Verification Admin – USA Swimming is working on the double registrations causing problems in SWIMS.

II. Chairperson Reports

- C. Senior Vice Chair – 1. Oahu Swimposium went well, a big mahalo to Stephanie Monahan for helping coordinate the event. 2. Senior Championship Meet notice and File are posted. No OME this year. Eric proposes to increase hospitality reimbursement to \$1000 per day for championship meets. The costs of goods have increased significantly. AG Champs hospitality was \$3500 for the entire meet and we purposely went very barebones on lunches/snacks and coaches/officials were not happy. OSL had to pay almost as much as the LSC for hospitality but the OSL did not get any money for hosting the meet.
Jon is suggesting increasing the surcharge for the meet. Dave suggested OSL show some documentation of their expenses. Then OSL can make a motion at HOD to increase the day-to-day budget.
- D. Age Group Chair – Age Group Champs will be February 16-19 at VMAC. Jon asked Reid about JAGS. If we do have JAGS, it will most likely be on the Big Island. Joyce Follis is wanting it at KONA KCAC. Most likely be at the earliest end of February.
- E. Technical Planning Chair – Everything is uploaded except the MAGSA meet yesterday.
- F. Safe Sport Chair – Jon said Safe Sport is the body with the task of reviewing coaches, officials, etc. for eligibility. This will be done by the National organization for Safe Sport.
