### I. Administrative Reports

- A. Secretary Minutes August minutes in the google doc folder. APPROVED
- B. Treasurer Report reports in google doc folder. Attached to the end of the minutes.
- C. Registration reports in google doc folder and attached to the minutes. It's suggested that families don't wait until December to register their

- athletes. There may be a backlog which may cause trouble. Coaches should also be aware of this.
- D. National Times Verification Admin uploaded 2 meets from yesterday. Awaiting MAGSA's meet. All other meets are updated. Need requests for observed meets for high school swimming. When submitting a sanction and uploading it into USA Swimming database, if the pool isn't listed, need to ask Gwenn to upload the pool and contact information. Then you will be able to upload the meet into the database.

### II. Chairperson Reports

- A. Admin Vice Chair nothing to report
- B. Finance Vice Chair They want to move the endowment funds. Eric suggested he and his committee get together and put a motion together on what they'd like to do with the money. Eugene is hoping to have the budget completed by December.
- C. Senior Vice Chair Senior Champs info is posted on the website. The meet is starting an hour earlier on Sunday for finals. The meet will be at UH. Eric went to UH yesterday, the LC pool looks great, they are dealing with algae in the SC pool. They are resurfacing the bleachers. It will all be done by Senior Champs.
- D. Age Group Chair nothing to report
- E. Technical Planning Chair Working on time standards.
- F. Safe Sport Chair There is a Safe Sport Chairs virtual meeting November 11<sup>th</sup> 3:00-6:00pm EST. They will share new resources for Safe Sport and have a chance to collaborate with each other.
- G. DEI Chair National Diversity Camp will be in Indy July 17-20, 2024. Each LSC may send two athletes and two non-athletes (DEI Chair and a member of leadership). LSC is responsible for camp fee (\$425 per attendee) and Travel. Joyce will send out the information.
- H. Officials' Chair Stephanie is working with the officials regarding R9 that was passed at the USA Swimming HOD.

 Governance Chair – Jon updated the By-Laws and sent to Eric and Malcolm for review. He needs to get the USA Swimming By-Laws because our numbering isn't correct. He's also updating the P&P and sending out for review.

### **III.** Representative Member Reports

- A. Coach Representative nothing to report
- B. Officials' Representative no report
- C. Athletes Representative nothing to report
- D. At-Large Maui Representative nothing to report
- E. At-Large Hawaii Island Representative BIS had a pentathlon yesterday which was well received. It was held at Hilo High School which is the first time they've used it in six years. He's hoping that will be another resource for hosting meets. The KCAC pool looks fantastic. They are hoping to do a test run with the equipment January 6 prior to the State Championships.
- F. At-Large Oahu Representative for novice meets, they divided the island into 3 sections which includes 3-4 clubs. They are to run their own novice meets. They are using low tech meets so they can host them at pools where they normally don't have the equipment. These meets are only one hour and are for C times and slower swimmers.

### IV. Old Business:

- ASCA Clinic is set for April 19-21<sup>st</sup> at HPA. There will be three presenters.
   The LSC will be required to pay a fee to host the clinic. It will go directly to ASCA.
- 2. Credit card update...Eric has turned everything in so far to Barclay.
- ADHOC committee has met twice discussing time standards. They've looked at other LSCs of the same size to see what they're doing for time standards.
- 4. Sanction process form has been cleaned up. There is now a standardized meet notice form.

### V. New Business:

1. Swim Kauai wants to host an Invitational. Brad Meacham spoke on this. Because of HISI format for time standards, they'd like to be able to get bonus swims and the SKA swimmers to not have to have a met time standard, etc. It's a prelim/final meet on December 8-10. They are trying to put together a bigger meet. They expect over 130 swimmers from California plus teams from neighbor islands. SKA wants to develop a travel fund. Motion to the BOD to consider this as a nonconforming meet and not an Invitational which will allow them to have this meet. MOTION APPROVED

The fees will remain the same as an Invitational.

- 2. Finance committee wants to get our funds out of First Western. Eugene made a motion to take the Endowment Fund out of First Western. The reasoning is the bank has not been active in discussing the huge loss we endured. Morgan Stanley has sent a proposal. Eugene is going to look into Schwab and Fidelity. Jon suggested we table this motion until they have the institution our funds will be transferred to. Eugene will reach out to the BOD when he receives the information.
- Annual internal audit report was done. There is one exception that needs to be approved by the BOD. There was a check written to KONA Aquatics for \$20,000. It was never formally approved. Motionallow this exception for approval. MOTION APPROVED
- 4. The Executive Committee met regarding USA Swimming proposal for the LSC to contribute to Lahaina. USA Swimming will be providing \$10,000. USA Swimming wants HISI to contribute at least 20%. Eric made a motion for HISI to match the funds. MOTION APPROVED
- Waiving Lahaina Swim Club meet fees for short course 2023 to the end of 2024 long course season. Motion made for Lahaina meet fees to be waived. Friendly amendment made for the MAGSA meets and

- Championship meets fees waived. MOTION with amendment APPROVED.
- 6. Kenny Chew gave Eric the financial records from 2010-2014. Deborah said we do not have to keep the records that are bank statements, deposits, and checks written that are over 7 years old. The tax info and important documents will remain with HISI. Motion made to destroy the non-essential financial documents/forms. MOTION APPROVED
- 7. The HOD is next month. Eric will be proposing an amendment to our By-Laws to extend term limits to 4 years for key positions (such as General Chair, Admin Chair, and Finance Chair) on the BOD. This will begin in 2025 if approved. Eric will send out a notice to all HOD delegates regarding the HOD meeting and he will include his proposal.
