RULES: Current USA Swimming technical rules and IASI policies and procedures will govern

this meet.

FACILITY: The competition course has been certified in accordance with Rule 104.2.2C(4) of USA

Swimming Rules and Regulations. The certification is on file with USA Swimming.

The Dubuque Community Schools Aquatic Center features:

- The pool is 40 yds. long by 25 yards wide with a moveable bulkhead
- Racing course will be set for eight nine-foot wide 25-yard lanes turning at the bulkhead, with an additional five 25-yard eight-foot wide lanes for warm-up and cool-down
- Twelve-foot deep at the starting end and seven-feet deep at the turn end
- Paragon starting blocks that include wedges and side rails
- Spectrum Backstroke wedges are available for each lane, for 13 & older sessions.
- Daktronics Timing System with eight-foot touch pads, one button backup and pool-side speakers
- Daktronics Eight-Lane Timing & Video Display Board
- Stadium seating for 350 spectators.

- Parking available around the Aquatic Center
- For some sessions, there will be a gymnasium available for a "crash area", near spectator seating, depending on DCSD use.
- Medical Supervision: None

COACHES:

Only currently registered USA Swimming coach members will be permitted on deck in designated areas. Each coach must sign the Coaches Meet Sign-In (APP-29).

WARM-UPS:

The IASI mandatory warm-up procedure will be followed in accordance with the IASI Code Book. The pool will be cleared 5 minutes prior to competition.

All swimmers must be under the supervision of a USA Swimming member coach during warm-up, competition, and warm-down. The Meet Director or Meet Referee may assist the swimmer in making arrangements for such supervision, but it is the swimmer's responsibility to make such arrangements prior to the start of the meet.

RACING STARTS:

Any swimmer entered in the meet must be certified by a USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water without the use of a backstroke ledge. When unaccompanied by a member coach, it is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.

ENTRY REQUIREMENTS:

- 1. Swimmers must be currently registered as athlete members of USA Swimming in order to compete in this meet. 18 & older swimmers must be current on Athlete Protection Training (APT).
- 2. Because of the format of this meet, MANY events are offered on the same day based on what you'll see in the sign-up. HOWEVER, swimmers may only swim the following session &/or daily limits;
 - S1- Friday Night Prelims 3 events
 - S2 Saturday Morning Prelims 3 events, UNLESS entering Sunday 1650 Freestyle, then only 2 in Saturday Morning Prelims.
 - S3 Saturday Afternoon 12 & Under NO events, IF they swam Friday night OR Saturday morning prelims. Otherwise, they may swim up to 5 events.
 - S4 Saturday Night Finals from Friday Night Prelims (top-32 advance)
 - S5 Sunday Morning Finals from Saturday Morning Prelims (top-32 advance) and 1650 if desired.
 - S6 Sunday Afternoon 12 & Under NO events, IF swimming in Morning Finals. Otherwise, they may swim up to 4 events..
- 3. Seed times must be submitted for a 25yd. course. Converted times are not allowed. If a swimmer does not have a recorded time for an event, please enter NT.
- 4. 12 & Under swimmers may only swim in prelim/finals (as Senior) OR in the afternoon timed finals on the same day, not in both.

ENTRY FEES & SUBMISSION:

Entry fees are as follows:

- 1. Individual events: \$8.00 per event for Prelim / Final events / \$6.00 per event for Timed Final events.
- 2. IASI swimmer surcharge: \$6.00 per swimmer.
- 3. Manual entries (for teams entering more than five swimmers): \$2.00 per swimmer.
- 4. The entry fee for each swimmer who qualifies for LSC outreach benefits is \$5.00 and covers all individual events swum by the outreach swimmer. The IASI swimmer surcharge is not assessed on outreach swimmers.

Electronic entries must be submitted in a format compatible with HY-TEK Meet Manager software. All other entries require manual input and must be submitted on the IASI Meet Entry Form (APP-7).

Clubs entering outreach swimmers should only provide the number of outreach swimmers and the number of events being swum by the outreach swimmers to the host club. The names of the outreach swimmers are not to be provided to the host club.

Submit entries along with the appropriate IASI Financial Sheet (APP-8.1). If submitting electronic entries, also send a hardcopy of the entries with the entry fees and financial sheet.

Payment shall be by check made payable to Dubuque Area Swimmin' Hurricanes.

All entry fees, including IASI swimmer surcharge fee, should be combined on one check. The host club reserves the right to require payment by money order or cashier's check. Entry fees are non-refundable; IASI swimmer surcharge fees will be refunded only if the entire meet is canceled.

ENTRY DATES AND DEADLINES:

- 1. Entries will be accepted only from IASI teams and IASI affiliated unattached swimmers beginning at 1:00 p.m. on Monday, October 9, 2023.
- 2. All other entries will be accepted beginning at 1:00 p.m. on Monday, October 16, 2023.
- 3. Manual entries, along with entry fees and financial sheet, must be received no later than Wednesday, November 8, 2023.
- 4. Electronic entries must be received no later than Noon, Friday, November 10, 2023. A hardcopy of the entries, along with entry fees and financial sheet, must be received by Wednesday, November 15, 2023. Failure to submit the hardcopy and fees by this deadline could result in entries being scratched.
- 5. Entries *will not* be accepted by phone or fax.

LATE ENTRIES:

Late entries WILL NOT be accepted.

SWIMMERS WITH DISABILITIES:

Swimmers with disabilities are encouraged to compete. The Information Form for Adapted Competitive Swimmers (APP-21) indicating limitations and requested modifications should be completed and attached to the meet entries. Modifications will be determined by the referee. The swimmer (or swimmer's coach) is responsible for providing any equipment or assistants required. See Article 105 of USA Swimming Rules and Regulations.

MEET

COMMITTEE:

A meet committee consisting of the Meet Director, Referee, a Coach Representative, an Athlete Representative, and a certified official acting at large will be established in accordance with IASI Policy & Procedures. The committee shall serve as the meet jury to consider any administrative protests filed at the meet. Protests against judgment decisions can only be considered by the Referee and the Referee's decision is final.

MEET OPERATION:

- 1. There will be NO Clerk of Course, however, volunteers will be stationed behind the starting area to help guide swimmers to their lanes.
- 2. Events may be combined to facilitate meet operation and separated later for results and scoring.
- 3. Prelim / Final events; 25 32 place prelim finishers will swim in the Extra Bonus "D" Final, 17 24 place prelim finishers will swim in the Bonus "C" final, 9 16 place prelim finishers will swim in the Consolation "B" Final and the 1 8 place prelim finishers in the Championship "A" Finals. See point "8" below for 50 Freestyle "Skins" procedure and explanation.
- 4. Deck changes are prohibited.

& 24 will be contested as follows:

- 5. The host is not responsible for providing rest for swimmers between events. If a swimmer has less than 10 minutes between swims, the swimmer (or swimmer's coach) should inform the referee.
- 6. Deck Pass or the USA Swimming app are acceptable proof of membership in USA Swimming. Coaches and Officials must produce proof of membership in USA Swimming immediately upon request by the Referee or his/her delegate or leave the pool deck.
- 7. Operation of a drone, or any other flying apparatus, is prohibited over the venue (pools, athlete/coach areas, spectator areas and open ceiling locker rooms) any time athletes, coaches, officials and/or spectators are present.

 8. For events 23 & 24, THE fastest eight (8) finishers from prelims will move forward in the "skins" competition. The finals heats of the 50 Free for events 23

Heat 1 - Girls "skins" Quarterfinals, positions 1 - 8 fastest

Heat 2 - Boys "skins" Quarterfinals, positions 1 - 8 fastest

Heat 3 - Girls Extra Bonus "D" final, positions 25 - 32

Heat 4 - Girls Bonus "C" final, positions 17 - 24

Heat 5 - Boys Extra Bonus "D" final, positions 25 - 32

Heat 6 - Boys Bonus "C" final, positions 17 - 24

Heat 7 - Girls "skins" Semi-finals, places 1 - 4 from Quarterfinals

Heat 8 - Boys "skins" Semi-finals, places 1 - 4 from Quarterfinals

Heat 9 - Girls Consolation "B" final, positions 9 - 16

Heat 10 - Boys Consolation "B" final, positions 9 - 16

Heat 11 - Girls "skins" Final, places 1 & 2 from Semi-finals

Heat 12 - Boys "skins" Final, places 1 & 2 from Semi-finals

- 9. Events 1 and 2 (500 Freestyles) and 11 & 12 (400 IMs) will be limited to the fastest 32 entries per event per gender. Should there be less than 32 in one gender, additional entries will be accepted until a total of 64 for both genders are entered. 10. Events 45 & 46 (1650 Freestyles) will be limited to the fastest 16 entries per event per gender. Should there be less than 16 in one gender, additional entries will be accepted until a total of 32 for both genders is entered.
- 11. The 1650 Freestyles are TIMED FINALS and will be swum fastest to slowest, alternating girls / boys heats, combined when possible.

SCORING: There will be PENTATHLON scoring for only the 12 & Under Saturday afternoon

> session. Points are NOT scored, but for each of these age groups and genders, the swimmer with the fastest combined overall time, having competed legally in all five

events, will be the PENTATHLON winner.

1st - 8th Ribbons for 12 & Younger events only AWARDS: **Individual Events**

> Pentathlon (Sat. afternoon) 1st place in each age group - Trophy

> "Skins" 50 Free 1st - 8th place - TBD Speedo prizes!

The IASI scratch rule is in effect. SCRATCHES:

NO SHOWS will be considered as an event contested and count toward the total.

USA SWIMMING REGISTRATION:

All swimmers must be members of USA Swimming. The meet host will notify teams if they have entered swimmers whose memberships cannot be verified through pre-meet reconciliation. Those swimmers must prove membership to the meet host by either (i) showing the athlete's member card from the USA Swimming mobile app or website, or (ii) demonstrating that the athlete appears on a current club roster report produced from SWIMS 3.0. Screenshots of the athlete's member card is NOT acceptable proof of membership. Any swimmer who fails to provide membership no later than 10 minutes prior to warm-ups for the first session in which they are entered to compete will not be permitted to compete, forfeits their entry fees, and will be administratively disqualified

from the entire meet.

USE OF AUDIO OR VISUAL RECORDING DEVICES, INCLUDING CELL CAMERAS:

PHONES, IS NOT PERMITTED AT ANY TIME IN CHANGING AREAS,

RESTROOMS, OR LOCKER ROOMS.

NO TOBACCO OR ALCOHOL:

ALL Dubuque Community School District property, including Hempstead High School, are "Tobacco Free" areas. The use of any tobacco products or alcohol is prohibited.

IMAGE RELEASE:

Participants consent to be photographed/filmed by any authorized photographer(s) and/or network(s) of IASI and/or the host club under conditions determined by the host club, and authorize the use of names, pictures, likenesses, and biographical information before, during or after the event to promote swimming. No awards received in this competition may be used for trade or financial gain.

ADDITIONAL INFORMATION:

<u>Programs</u>. Printed programs WILL NOT be sold at the meet. Programs will be posted on-line under the "meet landing page" of the TeamDASH website and sent to each entering team to disseminate to their families by 8 p.m., Wednesday, November 15, 2023. Each team will receive a copy of the program in the coaches' packet.

Results. Electronic results will be provided to all teams participating in the meet. Final results will be posted on the IASI and DASH websites. A hardcopy of the final results may be requested on the IASI Financial Sheet for an additional \$10.00.

Swim apparel/merchandise. Simply Swimming OR Splash Multi-sport will be available.

Spectator information. No admission for spectators. Free parking is available.
