Legislation of minimum number of officials for Dual and Instrasquad meets by 1

Few Items regarding Sanctioning of open water rules and regs--Every second year on USA website to look at.

- Certs/Recertifications
  - Extended National Certification of those that are expiring ny June until December of this year to give time for people t get to a meet OQM
  - Extending the time before CJ ST DR AR to take the online test is the minimum. Have delegates at the officials meeting there to get everyone to agree to restart the recertification clinics for LSC recerts.
    - QUESTIONS: Robert- provisional officials change in name on the website to temp. Officials.
    - Position introduced by USA swimming to allow coaches or athletes to certify as stroke and turn officials.--Allows them to be an official for 60 days after taking the online clinic and passing test and 1 session. Allows them to serve as ST and be recognized officials during quarantine.

      Protocols to limit number of officials on deck
    - Need officials for this Saturday and sign up is on ISI website
    - Robert questioned unsanctioned meets couldn't be approved because we went through a process only automatically sanctioned for certain organizations like YMCA has special request to USA swimming, has to go to nationals and too much of a process to go through.

  - Meet in Clinton. Robert was there and went pretty well. Also in Des Moines. Both meets ran relatively similar protocols: long course vs. short course has protocol for fly over starts and getting out vs swimming another lap and getting out.

    - (can't spit the whistle!)
  - Noone briefed kids on the whistle sounds prior to meet
  - Whistles used: Fox 40 whistle, Molten whistle, Sound Meter and check acme thunderer
