#### MEMBERSHIP AGREEMENT

**WHEREAS**, an agreement needs to be established and the general membership to allow for the common understanding of obligations and responsibilities.

Team Cap	MONTH OF PURCHASE	First is free then \$8 per cap	Swimmers are asked to wear our team cap when participating at meets to represent our team.
Swim Equipment	N/A	Varies	Please talk to your coach for more information regarding the equipment.
Home Meet Food Fee	Month of Meet	\$10 Per Meet or a Food Donation	This fee is to help offset the cost of the hospitality food and stock the concessions for home meets.
Late Payment Fee	16th of the month when account past due	\$30	Please keep your account current to avoid late fee charges.
Unworked Volunteer Hours	Billed in August	\$40 per unworked hour	*Each family is required to volunteer 10 hours per year to help host meets, help at away meets and help with other team events.
Meet Fees	Billed 1st of the month	Varies	Each meet has a surcharge of \$12-30 per swimmer. Each Event entered is \$3-\$5. This amount will be billed to your account upon registering for a meet and is non-refundable.
