# Head Coach Report: Candi 6-6:15

Facility update? No updates

### 6:15-6:40 President/ Vice President (Jaymi/Josh)

- New Treasurer position Alicia stepping down within 8 months Will step
  down in August. Jaymi will prepare and send an email that asks the
  membership if anyone with payroll experience is interested in this position.
  Alicia will help train and provide guidance before exiting.
- Would it save team \$ if Josh got credit towards dues instead of payroll and
  potentially help with "conflict of interest" as a coach? Megan brought up
  possible conflict of interest if voting board members are also on EAST's
  payroll. Candi, Jaymi, and Josh mentioned that there is nothing about this
  in the bylaws. Candi brought up other coaches on different teams having a
  voting right on the board, and might possibly want to address that later.

Megan believes that this needs to be addressed either way (pro or con) and put in the bylaws in case EAST membership takes issues with this. Since membership dues are determined by the board and coaches salary is paid by the membership dues, to have coaches on payroll sit and vote on the board can be seen as a conflict of interest. Left off as "will discuss at a later meeting"

This policy will be presented to the membership January 29, 2025.
