**Eligibility:** All swimmers must be currently registered with USA Swimming. USA Swimming deck registrations

will not be accepted.

Facility: 10 lane, 50 Meter indoor pool, permanent starting blocks (within new USA regulations), 7'6" at

starting end, non-turbulent lane lines, Colorado timing system, Four Color 10 lane electronic timing display. CTS backstroke start wedge systems may be used. Seating capacity for 650 spectators. The competition course has been certified in accordance with 104.2.2C(4). The copy of such

certification is on file with USA Swimming.

Pursuant to Wisconsin Swimming, Inc. mandate, all applicable adults participating in or associated with this meet, acknowledge that they are subject to the provisions of the USA Swimming Minor Athlete Abuse Prevention Policy ("MAAPP"), and that they understand that compliance with the MAAPP policy is a condition of participation in the conduct of this competition. A registered athlete member at a sanctioned/approved meet who is 18 years of age or older, who had not completed the Athlete Protection Training (APT) by the date of the swim, will not be able to upload into SWIMS. These athletes will also be considered "not in good standing" and can be subject to fines under Wisconsin Swimming Policy 11.2.1.

#### COVID-19 Safety Plan According to Rule 202.4.16:

This meet will operate according to any local guidelines. Any updates will be sent out to attending teams. Pool Capacity: There are currently no capacity restrictions at the RecPlex. Health Monitoring: It is expected that all swimmers, coaches, officials, and volunteers are COVID symptom free and without known exposure with someone with COVID symptoms or diagnosis within the last 10 days. Entry and Exit: Athletes, coaches, officials and volunteers will enter the pool through the Aqua Arena entrance of the RecPlex. Swimmers will travel onto the deck by walking through the locker rooms. Check in for officials and coaches will be in the Shark Room. Check in for volunteers will be in the Aqua Arena lobby. A meet marshal will be placed at the Aqua Desk to ensure that only athletes, coaches, officials, and volunteers are allowed past the Aqua Desk. Locker rooms: Locker rooms will be available for swimmers to use. Bathrooms will be cleaned regularly per RecPlex facilities safety plan. Spectators: Spectators are welcome. Warm-up: A meet marshal will be assigned to manage the warm-up lanes. Swimmers may be limited to the amount of warm-up/down time at the discretion of the meet referee. Volunteers and Officials: The following type of workers would be inside the facility: • Certified Officials • Lane Timers and Chief Timers • Meet Marshals • Meet Workers (Volunteer coordinator/floater, runner, Colorado operators)

#### **General Rules:**

Official current USA Swimming and WI LSC rules shall prevail at this meet. Age as of May 13th, 2022 will dictate swimmer age for the meet.

Schedule/Warm-ups: Friday:

Warm-up 4:30pm Meet Start 5:30pm Saturday and Sunday AM Sessions: Warm Up 8:00am Meet Start 9:00am **Saturday and Sunday PM Sessions:** Warm Up 1:00pm\* Meet Start 2:00pm\*

Wisconsin Swimming warm-up procedures will be in effect. Swimmers must enter the pool from the starting end using a three-point entry for warm-up. Each team will be assigned lanes for their use for Warm-ups. Violators of the Wisconsin Swimming warm-up procedures are subject to disqualifications. Warmup procedures will be finalized after the close of entries.

Any swimmer entered in the meet must be certified by a USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water. When unaccompanied by a member-coach, it is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.

#### **ENTRIES**:

This meet will be run using the HY-TEK MEET MANAGER. Export a meet entry file and email it as an attachment. Upon completion of the meet, results, a results file and a MM Backup file will be posted on our website. Please send a .pdf of your entry with your entry summary. Hand carry a check for entry fees. Checks are to be made payable to: Blue Devil Swim Club

#### **Entry Deadline:**

Participating teams may request an entry reservation form from the Meet Host. Entries will be a accepted in the order received until the meet has been filled. Teams not accepted into the meet

**Entry Limit:** 

Individuals are limited to a total of 8 individual events for the meet. Friday: 2 individual events max Saturday and Sunday: 3 individual events max per day, not including relays. Relay swimmers must be entered in at least one individual event.

All Friday Night Events and all 200 meters events on Saturday and Sunday may be subject to limitations to achieve an acceptable time line. A copy of the psych sheet for these events will be sent to each team via email so that affected swimmers may be notified. We will try to accommodate affected swimmers by allowing an entry change. Information about entry change will be sent to the email provided on the release form. The host team reserves the right to swim additional heats if time allows. The host club reserves the right to swim a heat comprised of its own swimmers after the cuts have been made.

**Disabilities:** Coaches are encouraged to inform Officials and the Meet Director of any disabled

swimmer's needs prior to warm-ups.

**Deck Entries:** Deck entries may be accepted at the discretion of the Meet Referee and Meet Directors where

space allows in existing heats. Deck entries are \$6.00 per individual event/\$12.00 per relay. Swimmers not already in the meet must pay the \$10 Admission Fee and \$11.00 WI LSC Splash Fee/RecPlex Fee, at time of entry. Fees must be paid when deck entering in the Shark Room by cash or

check payable to: Blue Devil Swim Club

Format: All events are pre-seeded timed finals. Breaks may be added, or events may be combined

(age/gender) at the discretion of meet management.

Timing System: A fully automatic Colorado System 6 timing system with manual back-up buttons and back-up

watches for each lane.

Timers: Volunteer timers will be provided by BDSC Parents, but visiting teams may be asked to provide

assistance with timers.

Waivers: Each swimmer must have a signed "RecPlex Liability Release Waiver/COVID-19 Disclaimer/Photo

Release" waiver and "Waiver of Liability, Release, and Indemnity Agreement According to Rule 202.6.6". If any athlete is under the age of 18, these waivers must be signed by a parent/guardian.

Teams may send one file with their teams signed waivers.

**Coaches Packet:** Coaches packets will be handed out upon arrival each session. Please be prepared to show your

USA coach's credentials upon arrival.

**Positive Check-in** This meet will be seeded prior to the start of each session after the close of positive check in by

the coaches. All teams should inform the entry chair of all known scratches by Friday, May 13th at 2:00pm. The entry chair will accept additional scratches for all sessions up to 40 minutes prior to

the start of that session. Swimmers swimming unattached from a team should check in at the timing table prior to the start of each session.

Awards: Ribbons for 1st-16th places will be given for 8 and under and 9-10 age groups. High point awards

for girls and boys 8&Under, 9-10, 11-12, 13-14, and 15&Over will be given. Ribbons and high point

awards must be picked up at the end of the meet in the Shark Room.

**Heat Sheet/** 

**Admission:** Heat sheets and estimated timelines will be posted on the BDSC website and emailed to each team

for free distribution to each club as soon as the meet is seeded.

**Food:** The RecPlex may have food and beverages available at concession areas during the meet. Coaches

and Officials working the meet will be provided complimentary food and drink in the hospitality

room

**Conduct:** All coaches are responsible for the conduct of their swimmers and will see that their club always

has proper supervision. Meet marshals have the authority to remove any swimmer and/or spectator from the meet for any violation such as improper behavior, damage to property, etc. No smoking on the premises. Please encourage your parents and swimmers to clean up after themselves. In accordance with the Federal Video Voyeurism Prevention Act of 2004 – the use of camera phones or video recording devices in the locker rooms is prohibited. Deck changing is

prohibited.

**Drone Use:** Operation of a drone or any other flying apparatus is prohibited over the venue (pool,

athlete's/coach areas, spectator area and open ceiling locker rooms) any time athletes, coaches,

officials and/or spectators are present.

First Aid: Report injuries to the Lifeguard Staff and Meet Director. First aid kit is located outside of the

Lifeguard office. Only authorized Rec Plex staff may administer care using this kit.

Lost & Found: Lost and found items will be placed in a drum at the Aqua Arena entrance marked "Lost and

Found". Items of value will remain locked in the Aquatics Managers office for identification. After

the meet, lost and found items will be donated to charity after 1 weeks' time.

**Meet Results:** A copy will be emailed to participating teams and posted on the BDSC website.

**Swim Supplies:** A vendor may be on site

**Facility Guidelines:** No coolers or portable chairs may be brought into the facility.
