Location: RecPlex Aqua Arena 9900 Terwall Terrace, Pleasant Prairie, WI 53158

Eligibility: All swimmers must be currently registered with USA Swimming. USA Swimming deck

registrations will not be accepted.

Facility: 10 lane, 25 yard indoor pool, permanent starting blocks (within new USA regulations), 7'6" at

starting end, non-turbulent lane lines, Colorado timing system, Four Color 10 lane electronic timing display. CTS backstroke start wedge systems may be used. Seating capacity for 650 spectators. The

Meet Host will ensure the required course dimensions.

MAAPP Policy: All adults participating in or associated with this meet acknowledge that they are subject to the

provisions of the USA Swimming Minor Athlete Abuse Prevention Policy ("MAAPP"), and that they understand that compliance with MAAPP is a condition of participation in the conduct of this competition. Times achieved by an athlete member at a sanctioned meet who is over 18 years of age who had not completed the Athlete Protection Training (or whose APT training had expired) by the date of the swim, will not be able to be uploaded to SWIMS. This includes participation as a member of a relay. These athletes will also be considered "not in good standing" and can be subject

to fines under Wisconsin Swimming Policy 11.2.1.

**General Rules:** Official current USA Swimming and WI LSC rules shall prevail at this meet. Age as of November 22,

2024 will dictate swimmer age for the meet.

Schedule/Warm-ups:

Friday PM Session: All Ages Warm-up 5:00pm Meet Start 6:00pm Saturday and Sunday Sessions: All Ages Warm Up 9:00am Meet Start 10:00am

Wisconsin Swimming warm-up procedures will be in effect. Warm-up will be 50 minutes long. Swimmers must enter the pool from the starting end using a three-point entry for warm-up. Each team will be assigned lanes for their use for Warm-ups. Violators of the Wisconsin Swimming warm-up procedures are subject to disqualifications. Warmup procedures will be finalized after the close of entries.

<sup>\*</sup> This is an approximation. Warm-up will begin at the end of the AM Session. Session will begin 1 hour after the beginning of Warm-up.

Any swimmer entered in the meet must be certified by a USA Swimming member-coach as being proficient in performing a racing start or must start each race from within the water without the use of the backstroke ledge. When unaccompanied by a member-coach, it is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.

**ENTRIES**:

Entries will be accepted by the Entry Chair starting at 8:00am, Monday, October 21st, 2024. Entries will be accepted in the order received until the meet has been filled. Teams not accepted into the meet will be notified as soon as it is determined that the meet is filled, and at least within 48 hours after the entry deadline. The entry deadline is November 11th, 2024 11:59 pm CST. All changes must be submitted before the entry deadline. **Entry Limit:** 

Individuals are limited to a total of 7 individual events and 4 relays for the meet. Friday: 1 individual event; Saturday and Sunday 3 individual and 2 relay events per day.

All Friday Night Events and all 200 yards events on Saturday and Sunday may be subject to limitations to achieve an acceptable timeline and max entries. A copy of the psych sheet for these events will be sent to each team via email so that affected swimmers may be notified. We will try to accommodate affected swimmers by allowing an entry change. Information about entry changes will be sent to the email provided on the release form. The host team reserves the right to swim additional heats if time allows. The host club reserves the right to swim a heat comprised of its own

swimmers after the cuts have been made.

**Disabilities:** Coaches are encouraged to inform Officials and the Meet Director of any disabled swimmer's

**Deck Entries:** Deck entries may be accepted for swimmers already entered in the meet at the discretion of the

All events will be Positive Check-in, timed finals. Breaks may be added, or events may be combined Format:

girls.

watches for each lane.

Timers: Volunteer timers will be provided by BDSC Parents, but visiting teams may be asked to provide

assistance with timers. Swimmers in the 1650 Freestyle must provide their own timer and counter.

Image Authorization: All participants agree to be filmed and photographed by the official photographer(s) and network(s)

of Wisconsin Swimming and the meet host under the conditions authored by Wisconsin and USA Swimming, and allow event organizers the right to use names, pictures, likenesses, and biographical information before, during or after the period of participation in this Wisconsin Swimming

competition to promote such competitions.

**Coaches Packet:** 

Coaches packets will be handed out upon arrival at each session. Please be prepared to show your USA coach's credentials upon arrival. The official mobile application of USA Swimming is acceptable proof of USA Swimming membership.

**Positive Check-in** 

All events will be Positive Check-in, timed finals. Check-in will close 20 min after the start of warm-up. Swimmers not checked in prior to the check-in deadline will be scratched from that session. Swimmers will be seeded slowest to fastest. In events of 400y or longer athletes will be seeded fastest to slowest. Swimmers in the 1650 Freestyle must provide their own timer and counter.

Awards:

Ribbons for 1st-10th places will be given in all individual events (relays not included) for 8 & Under, 9-10 and 11-12 age groups. The 1650 freestyle may not be included in the awards. Themed awards will be given for all ages  $1^{st} - 3^{rd}$  in the mixed relays. Ribbons must be picked up at the end of the meet in the Shark Room. Awards will not be mailed out.

**Heat Sheet/** 

Admission: Psych sheets and estimated timelines will be posted on the BDSC website and emailed to each team

for free distribution to each club as soon as possible. Heat Sheets will be posted on Meet Mobile.

Food: The RecPlex may have food and beverages available at concession areas during the meet. Coaches

and Officials working the meet will be provided complimentary food and drink in the hospitality

room

**Conduct:** All coaches are responsible for the conduct of their swimmers and will see that their club always

has proper supervision. Meet marshals have the authority to remove any swimmer and/or spectator from the meet for any violation such as improper behavior, damage to property, etc. No smoking on the premises. Please encourage your parents and swimmers to clean up after themselves. Use of audio or visual recording devices, including a cell phone, is not permitted in changing areas,

restrooms or locker rooms. Deck changing is prohibited.

**Drone Use:** Operation of a drone or any other flying apparatus is prohibited over the venue (pool,

athlete's/coach areas, spectator area and open ceiling locker rooms) any time athletes, coaches,

officials and/or spectators are present.

First Aid: Report injuries to the Lifeguard Staff and Meet Director. First aid kit is located outside of the

Lifeguard office. Only authorized Rec Plex staff may administer care using this kit.

**Lost & Found:** Lost and found items will be placed in a drum at the Aqua Arena entrance marked "Lost and Found".

Items of value will remain locked in the Aquatics Managers office for identification. After the meet,

lost and found items will be donated to charity after 1 weeks' time.

**Meet Results:** A copy will be emailed to participating teams and posted on the BDSC website.

**Swim Supplies:** A vendor may be on site

**Facility Guidelines:** No coolers or portable chairs may be brought into the facility.
