Location: West Chicago Community High School District #94 **Dan R Johnson Natatorium**, 326 Joliet St., West Chicago, Illinois; one mile north of Rt. 38. The school is a no-smoking facility. Likewise, there is no smoking allowed on the grounds.

Pool: The West Chicago Community High School District #94 **Dan R. Johnson Natatorium** is a 25-yard six lane pool with starting blocks at one end (depth at blocks: 10'-0"), non-turbulent lane lines, Daktronics horn start system and a LED Videoboard with six-lane read-out for results. Spectator seating will be limited in the pool area. The competition course has not been certified in accordance with 104.2.2C(4).

Positive check-in closes at 7:20 AM

Sunday 6: Warm-ups: Immediately following 5 session, not before Noon

First Splash: not before 1:00 PM Positive check-in closes at **12:20 PM**

Format - Timed finals with a positive check-in. Check-in Sheets will be posted 10 minutes prior to the start of the first warm round, and will be removed 40 minutes prior to the start of the session

Eligibility - All USA Swimming registered swimmers are eligible. All swimmers must be registered prior to entry deadline. Entries listed, as "Registration applied for" will not be accepted. There will be no on deck registration available at this meet. Swimmer's age on the first day of the meet determines age group for the entire competition.

Entry Deadline - Entries will not be accepted before Friday, October 18, 2024, at 8:00 a.m. Only team entries received by e-mail will be accepted. Entries will be on a first-received, first-entered basis. Entries received before the due date will be rejected.

Entries - Entry times should be in SCY. Teams must submit their entries in a Hy-Tek file, zipped in an e-mail. A signed release with fee summary must accompany the entry. Your Club's entire entry must be sent in one e-mail. E-mail entries to Dan Fors, danfors44@gmail.com

Entry Fees

\$5.00 per Individual event, \$10.00 per relay entered.

\$2.00 ISI Swimmer surcharge

\$15.00 A facility fee per athlete will be assessed. Please note there will be no charge for admissions or heat sheets to spectators.

Payment - Make all checks payable to West Chicago Sharks, Inc.

Entry Limits - Swimmers are limited to 2 events Friday, 4 individual events/1 relay per day on each Saturday and Sunday. Session 4: 1000 swimmers may by in 4 other individual events on Saturday.

Event Format - Timed finals with a positive check-in. Check-in Sheets will be posted prior to the start of warm ups, and will be removed 40 minutes prior to the start of the session. All events will be swum slowest to fastest, except the 1000.

Athletes with Disabilities - In accordance with USA Swimming Rules; Articles 105 and 202.1.13, the Meet Referee has the authority to accommodate swimmers with disabilities. It is the responsibility of the coaches or swimmers to contact the Meet Referee, prior to competition, with specific requests.

Spectator Information - Presuming there is no change in state or local guidance, spectators will be allowed at this meet. Admissions and heat sheets are included in the facility fee. Heat sheets will be made available without charge in an electronic format through Meet Mobile.

Warm-ups - Warm-up periods will be conducted under Illinois Swimming Rules and Policies. The meet director will email warm-up assignments a few days before the meet start date.

Results - Final results will be posted on the WCS website, and sent via e-mail to Participating Teams. Results thru Meet Mobile will likewise be available

Awards: Individual Events 1st thru 12th place overall for swimmer ages 6&U, 7, 8, 9, 10, 11 and 12 and all 12 & under Relay Events 1st thru 3rd. Heat winner bag tags will be given to all 12 and unders that win their heat(s).

Officials - USA Swimming officials who would like to work the meet should contact the Meet Referee.

Timers - Teams with more than 10 swimmers in a session may have an assigned lane to time for that session. Coaches will be e-mailed lane assignments prior to the meet.

Starts - At the Meet Referee's discretion, fly-over starts may be implemented in order to ensure that each session is completed in a timely manner.

Rules - All current USA Swimming and ISI Rules and Regulations apply including the following:

- Safety: All ISI and USA Swimming safety rules will be strictly enforced.
- Drones: Operation of a drone, or any other flying apparatus, is prohibited over the venue (pools, athlete/coach areas, spectator areas and open ceiling locker rooms) any time athletes, coaches, officials and/or spectators are present.
- USA Swimming Insurance regulations require that all Swimmers, Coaches, Judges,
 Membership Starters, and Referees be current members of USA Swimming, Inc. It is each
 club's responsibility to register their Swimmers, Coaches and, Officials. Swimmers, Coaches
 and Officials who are not current members of USA Swimming, Inc. may not participate in the
 meet or be on the pool deck. Coaches and Officials will be asked to sign in and show
 credentials before entering pool deck.
- All applicable adults participating in or associated with this meet, acknowledge that they are subject to the provisions of the USA Swimming Minor Athlete Abuse Prevention Policy ("MAAPP"), and that they understand that compliance with the MAAPP policy is a condition of participation in the conduct of this competition.
- The use of audio or visual recording devices, including a cell phone, is not permitted in changing areas, behind the starting blocks, rest rooms or locker rooms.
- Per Illinois Swimming "Any swimmer entered in the meet must be certified by a USA Swimming member-coach as being proficient in performing a racing start or must start each race from within the water. When unaccompanied by a member coach, it is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.
- NO DECK OR BLEACHER CHANGING: Except where venue facilities require otherwise, changing into or out of swimsuits other than in the locker rooms or other designated areas is prohibited
