

# West Chicago Sharks Board of Directors Meeting Monday, October 5th, 2015

Meeting called to order at 7:02 by Kim Rockwood

Kim motioned to approve the September minutes, and Dave seconded. The minutes were approved.

## **Registration (Dennis)**

 Current registration is 137 swimmers, with \$22,190 in receivables. This compares to a final count of 174 swimmers for Winter 2014, but many of the high school girls are not yet registered.
Many of this year's swimmers are new families. Many were referrals from both Bear Paddle Swim School and Goldfish Swim School.

## Coaches (DJ)

- DJ will coordinate the hospitality room structural changes for Christmas break.
- Fox entries are due on Wednesday, October 7<sup>th</sup>.
- Right now there seems to be a good balance and mix among the different practice groups.
- DJ and Dave run the parent meetings, and we had good attendance.
- DJ has been asked by the ISI General Chair to join the Central Zones Board of Review.
- DJ provided an overview of his retirement plan, timing of an announcement, and his thoughts on succession plans.
- Scoreboard:
  - Colorado Systems has more features than Daktronic
  - DJ reviewed pricing for 3 options, and the board agreed to pursue a 6'H x 12'W scoreboard, with a price of \$42,500. We will also need a new timing console and computer system, though DJ will confirm if those are included. We should still plan to budget \$50,000.

# Financials (Allen)

- Treasurer's Report
  - Total assets as of October 4<sup>th</sup> equals \$52,467.64. This includes \$5,000 in restricted cash toward the purchase of the scoreboard.
  - o Key deposits for the month include:
    - \$900 Manna



- \$1,596 membership dues
- \$8,204 2016 ISI/USA registration fees
- o Key expenditures for the month include:
  - \$10,850 contract services for coaching expenses
  - \$2,100 pool rental
  - \$3,564 ISI/USA registration fees
- o ISI/USA registration fees deposits and expenses are for the first group of 54 swimmers, which represents 33 returning swimmers and 21 new swimmers. The total per swimmer was \$66.00, broken out into a registration fee of \$54.00 and an LSC fee of \$12.00.
- Allen will be meeting with Chris Plagge to review tax form information.

#### Ways and Means (Kim)

- Our October Manna order is currently \$1,000 but some other orders may come in.
- We will need to recruit for a new VP of Ways and Means to replace Kathy Koester.\
- The board agreed to use a new vendor for pie orders as Market Day was bought out. Kathy Draughon will coordinate pie sales.

- Job sign-up for our first dual meet is filling up.
