

West Chicago Sharks Board of Directors Meeting Monday, November 2nd, 2015

Meeting called to order at 7:00 by Kim Rockwood

Dave motioned to approve the September minutes, and DJ seconded. The minutes were approved.

Registration (Dennis)

- Current registration is 157 swimmers, with \$24,920 in receivables. This compares to a final count of 174 swimmers for Winter 2014, but many of the high school girls are not yet registered. Of the receivables, \$21,830 has been paid.
- Group assignments have been updated for swimmers as a result of test sets.
- Two swimmers in the water have not yet registered.

Coaches (DJ)

- Structural improvements are on track for holiday break.
- Stroke camps went well and registration numbers look good with balanced groups.
- Registrations went in today for the Fox meet
- Fall Fling entries look good, with 631 swimmers including 140 from our team. We will get \$14,784 in entry fees, and the timelines look comfortable.
- From the House of Delegates meeting, next summer's Senior Champs meet will be moved back
 1 week. This happens every 4 years due to Olympic Trials. Sr. Champs will now conflict with
 Zones.
- Illinois Swimming created two sets of qualifying standards, tied to 8 or 10 lane pools, to balance the numbers between short course and long course championship meets.
- Meet fees will be increasing for championship meets.
- December 1st is long course meet deadline. DJ will coordinate with Bridget and Kim.



Financials (Allen)

- Account balances total \$60,168.10 on November 2nd, included \$30,431.58 in money market, \$24,736.52 in checking, and \$5,000.00 in restricted funds.
- Checking account deposits for the month:
 - \$970 payment for Manna
 - \$244 checks for membership dues
 - \$9566.06 credit card deposits for 2016 ISI/USA registration fees. (This is batches 2, 3, and 4 of processing.)
 - \$4,647.00 gross amount for pie sales fundraiser
- Key checking account expenditures for the month:
 - \$10,850.00 contract coaching expenses
 - \$1,022.85 Manna payment
 - \$672.00 hourly coaching expenses (to help Kara with Gold and Silver groups)
 - \$6,204.00 ISI/USA registration fees (This is batches 2, 3, and 4 of processing).
 - \$910.00 ISI payment, including \$250 for 2016 charter fees and \$660 for 10 nonathlete coaches
- Fundraising
 - Manna: \$79.54 for September, of which \$19.84 are WCS proceeds, and \$77.15 for October, of which \$19.24 are WCS proceeds
 - o 2015 Pie Sales proceeds of \$1,405.20 and cash donation of \$50.00

Ways and Means (Kim, for Kathy Koester)

- Our November Manna order is currently \$1,800 but some other orders may come in.
- Pie sales are a bit smaller than previous years.
- DJ and Kim are in talks with a good candidate to replace Kathy as VP Ways and Means.

 - Registration, jobs, and concessions and hospitality are all online
- T-shirt vendor and Swim Team Store are confirmed, and Maui Wowi is pending, as we're trying to find a new local franchise.
