

# West Chicago Sharks Board of Directors Meeting Tuesday, December 15<sup>th</sup>, 2015

DJ motioned to approve the November minutes, and Dave seconded. The minutes were approved.

#### VP, Ways & Means

Kim announced the appointment of John White as the new Vice President, Ways & Means. Thank you to Kathy Koester for her many years of service to the Sharks in this roll.

### **Registration (Dennis)**

• Current registration is 166 swimmers, compared to 174 in 2014. However, with the increase in group fees last year, receivables per month are up slightly, at \$26,473 compared to \$26,014 last year.

#### Coaches (DJ)

- New meet: A new meet was added for the weekend of January 16-17. It is hosted by Oak Park
  and will be held at UIC. We will not be sending coaches, so any interested swimmers will swim
  unattached.
- Polar Bear updates:
  - There are 380 swimmers registered, with entry fees just over \$10,000. We should have a generous timeline for each session.
  - DJ ordered 400 towels in lieu of awards.
- The project to revamp the hospitality room is on hold until summer.
- Garrett Clasen just returned from a successful meet at Junior Nationals.



### Financials (Allen)

- Account balances include \$21,669.08 in money market, \$25,500 in checking, and \$4,689.66 in restricted funds. The restricted funds is lower than previous months due to purchasing chairs for the hospitality room.

### **Meet Director Report (Bridget):**



- Fall Fling was our most profitable meet in recent years, generating \$21,295.15 in profit. That figure will go up as we are waiting on a check from Ocean's Apparel.
- Pauline and Debbie discussed the need for an email to families reminding them of their volunteer commitments. DJ will send that out.

## Ways and Means (Kim, for Kathy Koester and John White)

- Laura indicated that \$816 was contributed toward coaches gifts
- We received good feedback from our fall pie sales. We received 35% back from the vendor, and missed the next level of 50% by 60 pies.
- Scoreboard project:
  - DJ has an estimate of \$50,000.
  - Carol reviewed options for commemorative apparel and items to be sold or given to higher level contributors. Kim moved that the board authorize \$1,000 for Carol to purchase items to begin selling at the Alumni Meet.
  - Kim Gerster indicated that GoFundMe will take 8% of online contributions as their fee,
     while YouCaring will take 2.9% plus \$0.30 per contribution.
  - Kate suggested a tagline of '60k for 60 years'
- The scoreboard committee will meet on December 19<sup>th</sup> at 9:00 am.

## Planning & Scheduling (Dave):

- Wredling Middle School has invited WCS to participate in their Summer Activities Fair, to be held in March. This will cost \$50.00 at a minimum, but the fee could go up if we want electronics.
- USA Swimming Club Recognition: The requirements for club recognition are very complex and time consuming. After weighing these requirements against any potential benefits, the board voted to not pursue this effort. However, many of the items should be pursued as best practices for club management.

### Old Business (All):

• The last team suit orders have been received and delivered to families.
