## **Rules That Govern YMCA Competitive Sports**

This document establishes the rules by which YMCA competitive sports are to operate. Issued by YMCA of the USA, these rules address the purpose of competitive sports in the YMCA, eligibility, governance, YMCA affiliation and brand fidelity. They establish the basis of fair competition among YMCA teams and apply to the activities of YMCA affiliated teams in both closed and open competition.

The Rules That Govern document has been updated as of October 2025, with some new rules and several rules in which existing language was clarified or strengthened.

All YMCA coaches, officials, supervisors and leadership staff are responsible for reading and following the Rules That Govern.

## **Swimming Addendum to the Rules That Govern**

This document expands on the Rules That Govern, putting those rules into swimming terms. This is an extension of the Rules That Govern. The updated document will be posted by Dec. 1.

#### **YMCA Sanctioned Meet Rules**

The rules for YMCA sanctioned invitational and championship meets is also updated to reflect the Rules That Govern. It will be posted by Dec. 1. The deadline to submit a sanction request is 45 days prior to the start of a meet. Meet information may not be distributed or posted until the sanction is issued. Meet directors are responsible for ensuring the rules are followed, checking team and coach registrations, checking that each 18 & older athlete has completed Athlete Protection Training, submitting results and the signed declaration form from the CEO of each team participating.

# 2025-26 YMCA Team & Coach Registration

 Annual Y team and coach registration – This is for ALL teams and coaches. Team registration is \$50/year and coach registration is free until Dec. 1 and then includes a \$100/coach charge to your YMCA. These are also required for participation in all sanctioned Y meets. Registration link HERE.

\*\*\*If you are experiencing difficulty in accessing registration, please contact your Regional Representative for your team's direct URL. There is currently a glitch in the system but your Regional Representative can assist.\*\*\*

- Team registration Provides valuable data on the size and scope of Y swimming in the U.S. Please review your team information and update annually. Make sure to update your officials coordinator, aquatics director and executive director. In accordance with the Rules That Govern YMCA Competitive Sports, your team name should include your YMCA name.
- Coach registration Not only ensures all coaches are certified to be on deck, but national and regional communication is sent only to registered coaches and to aquatics directors indicated on the team registration. After Dec. 1, only registered coaches will receive e-mails. Please refer to the YMCA Coach Certification Requirements document before updating or submitting certifications.
