\*\*\*This fee will be paid directly to USA/KY Swimming when registering with them. This will cover your swimmer's insurance.

### Long Course Fees

The schedule is set up for a total of three payments covering the cost of the entire long course season starting April 15 and ending July 31, 2023. Invoices will be emailed monthly around 1<sup>st</sup> of each month. **Once you have registered for the team, you are responsible for a long course fees regardless of participation. There is no month-to-month participation.** The long course fee is broken into 3 payments for your convenience only. These three monthly payments must be received by the 20<sup>th</sup> of each month or a late fee of \$25 will be incurred. Payments are required to be made via Team Unify automated system. Each account requires a credit/debit card to be associated with the account to cover fees each month.

### Discounted Fees

- 5% Reduction on Long Course Training Fee if Paid in full by May 10.
- 10% Reduction on 1<sup>st</sup> Additional Club Member\*
- 20% Reduction on 2<sup>nd</sup> Additional Club Member\*

\*This discount only applies to the 3 monthly payment option.

### CKA Club Fee & USA Registration Fee

- USA Registration Fees will be done directly with USA Swimming. You will receive an email upon registration with a link to register with USA Swimming directly. The fee you will pay directly to USA Swimming is \$95. CKA will no longer be able to process the registration for you.
  - For those families who are eligible; there is an Outreach USA/KY Swimming Membership. It is a reduction in USA/KY Swimming Membership Fees. Please request more info if you feel your family is eligible.
- The annual CKA Club Fee of \$80, which is due at the time of sign ups, covers administration fees for the Team Unify system that manages all of our communication within the team, two team T-shirts, and a team swim cap.

### CKA Hosted Meets

CKA will be hosting two long course meets during 2024, all families are expected to assist with the running of these meets. Full team participation is expected. Swimmers will be automatically signed for these meets and each family will be required to aide in volunteering for the meets.

### Additional Expenses

These are expenses associated with membership that include, but not limited to, meet entry fees, apparel, events, etc. Once meet entries have been sent to the host team, an invoice will be generated for those events to your account. Regardless of participation in the meet at that point, you will be responsible for meet fees. If for some reason the host team doesn't charge CKA for those entries that you don't swim, a credit will be applied to your account. If your swimmer skips or misses an event at the swim meet, you still will be charged for that event. Along with meet fees, a \$25 travel fee per away meet will be required for a partial coverage of coaching travel fees during the season. Additional expenses will be invoiced the month following any expense is incurred. Individual invoices will be generated for your review. While all swimmers are encouraged to attend a swim meet, swim meets are not required.
