There is hope that the Senior Circuit Meet might be revived in 2023 - IF this happens, this would be a good meet to have as OQM.

OTS is still only available to the Official's Chair in a temporary format. Donna is inputting official sessions worked. Goal is for OTS to update in Dec 2022/Jan 2023 and transition to a more permanent system.

Website - Donna requested that official committee members check out the website and send her feedback. She is aware that links are not active. Donna will continue to work with Mike on updating the website.

Newsletter - The goal is to distribute the first newsletter by Christmas.
