DISCUSSIONS HELD

- 1. June 2023 minutes were approved by Chad and Chuck.
- 2. Advancement of Officials in no order: Trainees will still have to train as a CJ before training as a Referee. Path Nationals is going through R9; which means standardized testing and requirements across all LSCs. For example, Southern California has real strict rules for advancement procedures, and it takes 10 yrs to become a Referee. Somewhere down south, they have rules to become a Referee within 2 yrs. They have only 4 sessions required before they can advance.
