Convention Highlights and Reports: No reports submitted.

USA Swimming HOD Legislation Changes:

- Ledges to be use for backstroke starts for every lane. Front start wedges need to be used for all lanes and same type of events example: all prelim final or all timed final events.
- Deck Changing is barred. Consequences are up to meet referee. Suggested consequences are: First time = warning. Second time = barred from next event. Third time = barred from meet. Effective Jan 1, 2015.

Proposals:

Proposal A: Seed Times at a Non-Championship meet with Qualifying Times

Proposed by: Julie Quass, CIA Registrar

Current: ISI teams may host, during a regular season, a non-championship (Regionals or State) meet with qualifying times, reserving the right to allow members of the host team which have not met the qualifying times to partipcate. For those host team members that did not meet the qualifying time, the seed time used for their swim was in the conforming course, thereby seeding them ahead of non-conforming qualifiers. (Section J.IX.3)

Proposal: At ISI Open (non-championship) meets with qualifying time standards, host teams who enter their swimmers who have not met the qualifying times, shall seed those swimmers with either the lowest non-conforming time standard (for that swimmer's age division and gender) or a "NT".

Rationale: This allows seeding of the meet according to swimmers' abilities. Swimmers who have not met the time standard will no longer be seeded faster than those swimmers who have met the time standard, regardless if the qualifying swimmers are entered with the non-conforming times.

Effective: Immediately

Motion. Second. Discussion: ISCA Supports. Athlete Committee Supports. Passed.

Proposal B: Publishing of Psych Sheet on Meet Mobile

Proposed by: Julie Quass, CIA Registrar

Current: Six days prior to the commencement of the ISI Long Course Championships, some team entries were published on Meet Mobile (Section J.VIII.C)

Proposal: Psych sheets for the ISI Championship meets shall be published or posted only after the final entry deadline has passed.

Rationale: By having some, but not all, entries into for the ISI Long Course Championships available on Meet Mobile, this may have given those teams whose entries weren't on Meet Mobile an unfair advantage by seeing what other swimmers were planning to swim.

Effective: Immediately

Motion. Second. Discussion: ISCA supports. Athlete Committee supports. Friendly amendment accepted. Passed

Proposal C: Addition of New Swimmers after a meet has filled and closed

Proposed by: Julie Quass, CIA Registrar

Current: A meet that has filled and closed either because the splash limit has been met or the USA Swimming session limit has been reached, still allows swimmers not entered at the time of closing to enter and compete in open lanes due to scratches and other reasons. (Section J.IV.B)

Proposal: When a meet has been declared filled and closed, either because the splash limit has been met, the session time limit has been reached, or any other reason, no new entrants will be permitted, regardless of the Late Entry Policy for that meet. Arrival of the meet entry deadline is not to be considered closing the meet to new entrants.

Rationale: The activity of allowing new swimmers to enter a meet after a meet has closed and turned away teams that wanted to participate is contradictory to the meaning of closing the meet.

Effective: Immediately

Motion. Second. Discussion: ISCA does not support. Athlete Committee supports. This would be nice for the team already in the meet. This may limit extra revenue for host team. What is in place now doesn't affect timeline. It's the hosts right to decide who fills empty lanes. As is stands, it is comparable to flying 'stand by'. All to Question – Passed. Motion failed, ballot count: 13/30.

Proposal D: Reconsider the Need for Multiple Summer Regional Sites

Proposed by: Julie Quass, CIA Registrar

Current: This summer, there were two sites for the 2014 Iowa Swimming Regional Finals and 8&Under Championships. While this may provide a geographical convenience for some swimmers, the 8&Under Championships are diluted and not truly a championship with two *&Under high point champions for each gender. Additionally, if a swimmer competing at this meet does not qualify for the state meet, this is effectively his/her championship meet. (Section K.I.A)

Proposal: There shall only be one (1) 8&Under Championship held during the summer. The site shall be one of the sites of the ISI Summer Regional Championships and shall be awarded at the time of voting for the ISI Meet Schedule

Rationale: This will provide a true championship meet for the 8&Under swimmers. This will also give the meet less of a 'last-chance' to qualify for State meet and more of a championship meet feel for the older swimmers for which this may be their final, championship meet of the season.

Effective: Immediately

Motion. Second. Discussion: ISCA does not support. Athlete Committee does not support. Too much extra staffing and travel. Better to have more 8&Unders receiving awards. Call to question – Passed. Motion failed.

Proposal E – Transparency of Meet Entries

Proposed by Julie Quass, CIA Registrar

Current: When meet entries are submitted to a meet host, entrants are dependent upon the host to confirm their entry and some hosts are not timely (24 hours) with either the acceptance or denial. Additionally, there is no way for the entering team to know the current capacity of a meet (how close is it to filing?) (Section J.IX.B.)

Proposal: Most meet hosts have a dedicated page with information regarding their meet. Post on this page the date/time stamp of each entering team and the current capacity of the meet.

Rationale: Because there is currently no transparency or dual confirmation of entry receipts, the host team may not accept teams in the order the entries are received (and no indication of this selective process noted in the meet invitation). Additionally, when a meet has met capacity, teams may still have the desire to enter more swimmers, but are denied as a result. Having more information about a meet will allow visiting teams to make adjustments/adapt to the situation and goodwill may be maintained as opposed being 'surprised' a meet has closed an disappointing swimmers that did not get in. With regard to dual confirmation, maybe there is a need to establish an email address at ISI (entries@isiswim.org) and equire all entries to copy this email address. Any entries that do not copy the address will be invalid and discarded. This way, ISI would have an independent copy to confirm the order in which entries were received for a meet in the event of a protest.

Motion. Second. Discussion: Athlete Committee does not support. ISCA does not support. This would be micromanaging. There are already steps to take if a team feels they were mistreated. Teams could always ask host for order this information. This creates more work for the host team. When a meet is sanctioned, host team is acknowledging all of the rules they need to follow including the ethical standards upon which they must conduct a meet. Vote can't be taken on proposal as worded – suggested to withdraw proposal. Host teams are already letting teams know whether they have received entries and let teams know asap if their entries are accepted. Motion was only intended to create more transparency. What is wrong with more transparency? What about if a team enters too early? Suggestion to withdraw proposal again. Motion withdrawn.
