ISI Board Members Present – Dave Joensen, Judy Hackney, Lucas Ferreira, Don Spellman, Aron Nakama, Jamie Langner, Paul Eure, Tony Hunter, Phil Barnes and Janet Warren. Also present was Elaine Sortor, ISI Office.

The meeting was called to order by General Chair, Dave Joensen at 3:00 pm.

Announcements

There were three late proposals provided at registration:

Proposal L-M: Meet Bids Meeting

Proposal L-N: Procedure for changing meet classification.

Proposal L-O: Sanction fee for closed invites.

A packet of Supplemental Information was also provided at registration.

There were no changes to agenda.

Dave began with a review of athlete registrations and noted the following hi-lites:

- a. Registrations have already exceeded the number of athletes over 2010 numbers. The LSC is growing and approaching record numbers without seasonal athletes factored in. Non-athlete registrations for coaches and officials is down over 2010.
- b. Performance was good with 19 state records set.
- c. Iowa Swimming hosted a regional coaching clinic with USA Swimming for our LSC. Approximately 130 coaches attended and it was the largest clinic ever held.
- d. Iowa Swimming has a new web-site provided by Team Unify. It is easier to update from an administrator standpoint.
- e. An update on USA Swimming's LEAP assessment tool was given. LEAP refers to LSC Evaluation & Achievement Program. It focuses on four key areas including Business Plan, Coaching, Planning & Athletes. Level 1 is complete as required to be met once within each quadrenium. We can now proceed with Level 2 and 3 where incentives can be earned based on our number of registered athletes.
- f. 2011 Speedo Sectionals will be held at UI. It is the first time they will be held in Iowa in the 10 year history of Sectionals.
- g. Central Zones Select Camp will be at Miami, Ohio. 2 Iowa swimmers are to attend: Alec Martin, CIA & Haden Calegan, UN, Megan Ostings, IFLY coach assistant.
- h. 4 new clubs were formed: Pella, Lane 4, Indianola & Waukee which is in the final stages for approval.

Minutes: The minutes from the previous HOD dated November 7, 2010 were motioned, seconded and approved as submitted.

Treasurer's Report: None.

Annual Budget: The annual budget for the fiscal year September 2011 through August 2012 was presented. Travel is budgeted to be the same. An increase in athlete registrations is projected contributing to a \$7000 annual budgeted surplus. The elimination of a bus to Zones was reallocated into Professional Development, i.e.) Coach Clinic which was held.

Proposal E – Age Group SCY Championship Format – Tabled from HOD 11/7/2010

Proposal has been updated to a new effective date of Summer, 2011.

An event list and time line is needed before moving forward. The proposal was perceived as too broad. Further clarification is needed. Proposal E withdrawn until more detail can be provided.

New Business

2011-2012 Meet Schedule Approval – Admin VC. By February, 2012 ISI is required to have 3 Regional meets. New bid to accept a third regional meet to be hosted by CIA/BLAZE and placed on the schedule. A correction was noted the Ames meet to be held Sat & Sun, 10/22-10/23. Motioned. Second. Approved as amended.

14 & U Zones – Summer 2011. To be held August 5-7 at UIPUI, Indianapolis, IN. Open Water event will be on Aug 8.

Senior Zones – Summer 2011. August 4-7 in Franklin, IN. Open Water event will be on Aug 8.

ISI Policy on Inclusion of Swimmers with a Disability. There was a request at the last championship meet to include an amputee swimmer. Currently a policy is being drafted to include athletes who do not meet time current standards. A copy of the draft was included in the HOD materials packet. The Michigan LSC Disability Chair is being consulted and the use of Pan Am time standards.

CHAMPIONSHIP MEET PROPOSALS

Proposal A – Timer Allocation at ISI State Championship Meets

Proposed by Phil Barnes, ISI Officials Chair; Daming Zhu, IFLY; Matthew Yao, IFLY

Current Policy: Current ISI rules permit the ISI Championship meet host club to require the visiting teams to provide

up to 50% of timers.

Proposal: When allocating team timer requirements for ISI State Championship meets, consider timers as

officials; compute the number of officials/timers required from each visiting team for ISI State Championship meets and Regionals based on the number of participating swimmers from that team provided that the officials have volunteered prior to meet entry deadline. A visiting team could provide timers/and/or other officials to meet the allocation for the number of volunteers.

Rationale: 1. Swimmers should have the best mix of officials available to support them at a meet and clubs

should be encouraged to provide officials to support the meet.

2. Officials are volunteers supporting a meet like timers.

3. The current policy does not take into account the number of officials a club may be contributing to support a session and can result in certified officials serving as timers rather than officials in order to

meet the club's timer quota.

4. This change would help ensure a high quality of ISI Championship meets. Currently the hosting

club(s) often struggle to find enough officials to provide good coverage of the meets.

Effective: 2011 Summer Championship meets

Discussion: The goal is to have the best officials at championship meets. Timing requirements per team redirects

officials focus from officiating to timing. This is a change to a team's volunteer requirement recognizing officials as a fulfillment of their volunteer requirement. Officials need to sign up in

advance to count as volunteering. Officials are determined by meet referee.

A friendly amendment to include Regionals in addition to ISI State meet. Accepted.

Currently the best officials are determined by the meet referee. It may need to be determined at ISI board level. Further clarification was made on the number of officials/timers requirement. A friendly amendment to add allocation of team timer requirements was made. Accepted.

Motioned amended proposal. Second. Approved as amended.

Rationale:

There's a large number of entries submitted for state championship meets that are not in the SWIMS database. This approach would allow a fair and equitable manner for allowing entries using non-SWIMS times as proof of time (which are from unobserved meets). This change in the rules continues to allow non-SWIMS times to encourage YMCA, High School and recreational swimmers to participate in ISI Championship Swimming meets; however, this rule would not permit swimmers to use times from non-SWIMS database to be seeded faster than swimmers who have achieved their entry times at USA Swimming sanctioned or observed meets.



Effective: June 1, 2011

Discussion: The goal is to make all meets comparable. To present awards at more logical times so the meet flows smoothly and more timely. The intent is to award more medals through 4^{th} place. The awards were increased to 9^{th} – 16^{th} for 12&Unders. A concern was raised for the added cost of more awards at \$765 for 12&under, and \$1189 for summer champs. An additional \$.25/individual fees and \$.50/relays were proposed. However, the added profit would not completely offset costs. Accepted as a friendly amendment. Meet entry fees to be amended under Code Section I, \$5.00 to \$5.25/individual events and \$10.50/relays. The intent is for awards to be consistent and to reach more swimmers.

A friendly amendment was accepted to strike increase cost. The additional cost will be paid or subsidized by ISI. Even though the budget has been approved, ISI can authorize an additional expenditure. Therefore, ISI will pay for all of the awards for regionals & LSC championship meets in the state. A lot of expense is allocated to one line item in the budget.

Motioned amended proposal. Second. Motion fails.

Discussion on Original amendment to increase \$.25/individuals and \$.50/relays: Long course and next short course still in stock. Only applies to state championships. A separate Regionals proposal required to entertain fee increase on the same basis.

in using the A standard to separate "ISI Regional Championship" swimmers from "ISI Age Group

Championship" swimmers.

Proposal E – 8 & Under Regional Events

Proposed by: Paul Eure, ISI Technical Planning

Proposal: Eliminate 8 & Under A/B events (or A events if the preceding proposal has been passed) for 25 events

at the Regional Meets

Rationale: Separating 8 & Unders into two divisions (A/B and C) at the Regional Championships is a remnant of

the system before the 8 & Under age group was added to the state meet. ISI should be consistent in treating 8 & Unders like any other age group at the Regional Meet. The 25 yard distances are designed to develop swimmers who may struggle with 50s. Because A times have been chosen to distinguish ISI Age Group Championship Swimmers from Regional Championship in the 8 & Under age group, swimmers who have achieved the A time should no longer be considered developmental

and should not be allowed to swim those events at the Regional Championships.

Effective: 2011 Summer Regional Championship Meet

Discussion: Treat 8 & Unders like any other age group at the Regional Meet. A desire to retain the same format was

mentioned.

GENERAL PROPOSALS

Proposal G – Mandatory Warm-Up Procedure

Proposed by Jamie Langner, BLST

Proposal:

Change Section J, XI ISI Mandatory Warm-Up Procedure, E Split Warm-ups #4 – Multiple All Age Groups: Anytime there are 10&U warming up at the same time as 13 & overs, there shall be assigned as 13 & over lanes only and 10 & under lanes only, so that both age groups can have a good and safe warm up. The 11 & 12's can warm up with either age group. The meet host is to use the above formulas to determine how many lanes are needed for each age group. specific lane assignments based on age groups. Host Teams can select an option which best fits their needs.

- a) One option are lanes assigned as 10 and under only, 11-12 only, and 13 and older only
- b) Another option is lanes assigned as 10 and under only and 11 and older
- c) A third option are 12 and under lanes and 11 and older lanes. This give the 11 and 12 year olds options as to where to warm-up.

When there are no specified events for swimmers aged 10 and under (i.e. events are designated 'Open' or Senior') teams are not required to designate warm up lanes for 10 and under swimmers.

Rationale:

If a 10 & U is competent enough to swim in an older age group, they are competent enough to warm

up with the older age group.

Effective:

September 1, 2011

Discussion:

Friendly amendment to add Host teams. Several options proposed. ISCA endorses the addition of Host team. There is a noted difference between an open session and senior session. Ten year olds mixed with 16 year olds could pose a problem.

Motion. Second. Approved.

Proposal H – Q Time Standards

Proposed by Paul Eure, Technical Planning

Proposal:

Redesign the formula for creating Q times for 9-10, 11-12, and 13-14 age groups.

- ISI will bracket the Q times between National A times and BB times. ??
- New Q times will be established for the 2012 SC championship meets and re-established
 September 1, 2012 then every four years thereafter. beginning with the winter Age Group
 Championship Meet beginning in 2012. Changes in conjuction with our quadrannienal Nat'l
 time standards.
- Raising Time Standards
 - o In order to raise a standard, ISI has had to have averaged more than 32 swimmers in an event over the previous four years.
 - The new standard will be the average of the 32nd place times (rounded up to the nearest .09 seconds) over those years no faster than the National A standard.
- Lowering Time Standards
 - o In order to lower a time standard, ISI has had to have both
 - 1) Averaged less than 24 swimmers in an event over the past 4 years
 - 2) Had less than 24 swimmers in the event the previous year
 - In these instances, the new standard will reflect a 1% increase from the previous standard (rounded up to the nearest .09 seconds) no slower than the national BB time standard.
- In all other instances, there will be no change to the previous time standard

Rationale:

There is a great disparity of the number of ISI Age Group Championship Qualifiers in different events. As it is, some events have over 50 qualifiers and other have less than one full heat. This system will encourage a target of 4 to 5 heats (24 to 50 swimmers) in every event.

Effective: September 1, 2011

Discussion:

Two friendly amendments to establish Q times every four years beginning with September 1, 2012. A second friendly amendment to strike the first bullet, and establish Q times will not be faster than national A times & BB times. Q times are deferred to ISI technical planning committee to establish. ISCA supports the proposal with changes in languages. Changes should be added into Section I of code book.

Motion. Second. Approved as amended.

Proposal I – Meet Entries Time Frame

Proposed by Nick Lakin, BLST

Proposal: Iowa Team Time Frame for Meet Entries – All Only-ISI teams/athletes and athletes from teams that

attended the meet the previous year will be allowed to enter the meet during the first seven days

entries are accepted.

Rationale: Border teams that have long standing relationships with out of state teams were damaged by denying

them entry to meets they have attended for years. This allows those teams that come on an annual

basis to have a fair opportunity to get entry in to the meet.

Effective: September 1, 2011

Discussion: ISCA supports proposal. A friendly amendment to strike "athletes from" was accepted. The current

system allows Iowa swimmers first preference and to promote swimming. It also holds coaches

accountable and places the burden on the coach to enter swimmers by the due date.

Motion. Accepted. Approved as amended.

<u>Proposal J-a – Meet Definitions</u>

Proposed by Elaine Sortor, ISI Office

Proposal: Section J Meet Director, II. Meet Definitions

B. Closed Competition consists of Intrasquad, Dual, Triangular, or Closed Invitational.

These meets are closed to only those teams invited by the host club and can be scheduled at any time

(no bidding required. held with no bidding required.

For Dual, Triangular or Closed Invitational host club must receive written or electronic permission from member club(s) who are hosting meets on the desired weekend, weekend before and

weekend after said date(s).

Rationale: To protect host clubs who are hosting a scheduled invitational meet from teams holding a dual,

triangular or closed invitational the same weekend.

Effective: September 1, 2011

Discussion: More restrictive than J-b. J-b will be voted on if J-a voted down. If J-a approved, J-b vote not

needed. The added line at the end of the proposal protects the meet which went through the bidding process against meets which were added before or after bid meets. This proposal does not address weekday meets. Currently no permission is needed for weekday meets. Currently, requests go to the Admin VC & Sanction committee to approve and grant permission. Friendly amendment to strike

"Dual" accepted.

Not carried.

Proposal J-b – Meet Definitions

Proposed by Nick Lakin, BLST

Proposal: Closed Meet Sanctioning – To amend sentence that 'triangular and Closed Invites may be held any

time' to 'Closed Invites may be held only after being approved by any teams hosting an open invite

on that same weekend. Does not include Dual meets.

Rationale: Those going through the meet bid process should have control over the weekend gained during this

process. Closed Invites could be added only if the host team believes this meet will not affect the size

or quality of their meet.

Effective: September 1, 2011

Discussion: Permission is not needed from everyone surrounding the weekend of the meet, only meets from that

same weekend. Friendly amendment accept to include triangular. And friendly amendment to not

include Dual meets.

Motion. Accepted. Approved as amended.

Proposal K – Splash Fees

Proposed by Elaine Sortor, ISI Office

Proposal: Section I Meets, II Fees, B. Splash Fees

2. No splash fee will be collected for intrasquad, dual and triangular. meets.

Rationale: Dual and Triangular meets should collect splash fees as sanctioning, wrap up and ISI involvement is

the same as schedule meets.

Discussion: Same involvement from ISI office. Objection that it takes away from fun, low key meets.

Motion. Accepted. Approved by ballot.

Proposal L – Athlete Travel Reimbursement APP-18a

Proposed by Doug Colin, DASH

Proposal: Additional requirement added to the instructions on page 2-3 of the Athlete Application for Travel

Funds

ATHLETE TRAVEL REIMBURSEMENT

13. To receive ISI Athlete Travel Reimbursement funds, an athlete must show documentation of an overnight stay expense for each day during the competition for which the athlete is seeking reimbursement.

Rationale:

Travel reimbursement was intended to assist athletes and their families who have significant travel expenses when attending national level meets. ISI swimmers who have smaller travel expenses because they can sleep in their own homes during national level meets should not receive an expense reimbursement that is intended for those who had actual overnight travel expenses.

Notes:

- ISI athletes receive equal shares as long as the amount of expenses submitted is greater than the reimbursement share.
- Per ISI Athlete Travel Reimbursement instructions, swimmers may request up to \$25 per day in meal expenses without supplying receipts.
- Given the location of this summer's Speedo Sectionals and future national level meets held in Iowa, there is the potential for athletes to sleep in their own bed and eat while at home.

Effective: June 1, 2011.

Discussion: Athlete travel reimbursement was originally designed to reimburse for significant travel expenses out of town. A need to change the reimbursement is due to larger meets hosted locally.

Motion. Accepted. Approved.

Proposal L-M - Meet Bids Meeting

Proposed by Bobby Kelley, Lucas Ferreira

Proposal: Section J, Part III, Subsection C, Number 3:

- 1. The meet bid committee will be made up of one representative from each Iowa Swimming, Inc. member clubs that have bid meets. Said committee shall meet on the second Saturday in April (unless Easter weekend) at a location and time to be determined by the Admin Vice Chair. The meeting location must allow for member clubs to participate in this meeting via conference call or videoconference. In the event that the second Saturday in April is less than one week prior to the spring ISI House of Delegates (HOD) meeting, the bid committee meeting shall be moved up to be held at least one week prior to said HOD meeting. Notification as to time and place will be postmarked on or before March 25.
- 2. (Unchanged)
- 3. (Unchanged)
- 4. In order to be awarded meets, the member club must have a representative attend the meeting. Participation via conference call or videoconference shall suffice to match this attendance requirement.

Discussion: Friendly amendment to add "If technical difficulty with video conferencing occurs at the site of the

meeting, the meeting will be delayed one hour. An alternate to the meeting may be to call and

participate by phone. The meeting may continue by conference call if all agree.

Motion. Accepted. Approved as amended.

Note: Approval requires 90% in favor for late proposals.

Proposal L-N – Procedure for Changing Meet Classification

Proposed by Dave Joensen, General Chair and ISI BOD

Proposal: The following changes to Section J, Part III (Open Competition Bidding Procedure)

Section E of the ISI P/P manual shall be adopted.

1. Once the meet schedule is set and approved by the House of Delegates, **any proposed changes** *in type of meet (open or closed)*, length of meet, format, type of meet, location of meet, etc. must be requested in writing to requested and approved by the ISI Board of Directors, and by any teams hosting meets that same weekend, the weekend prior and the weekend after the meet in question.

2. E. If a team wants to drop a meet from the schedule, they may do so for a fee of \$50-\$200 payable to Iowa Swimming, Inc.

Rationale: The act of cancelling a meet creates a void in the schedule that was agreed upon by all teams. It can

greatly affect the opportunities available for swimmers and teams that cancel need to be penalized.

No penalty for teams that must cancel for conditions beyond their control.

Effective: Sept. 1, 2011

Discussion: A friendly amendment to strike etc. A second friendly amendment to add requested.

Motion. Second. Approved as amended.

Proposal L-O – Sanction Fee for Closed Invites

Proposed by Dave Joensen, General Chair and ISI BOD

Proposal: The following changes will take place to Section J-V – Meet Sanctioning section of ISI P/P manual.

E. Sanction Fee

\$5 Exhibition/Clinic; Intrasquad

\$20 Federation; Dual; Triangular; Closed Invitational

\$50 Invitational (open or closed), Triangular – One Day

\$100 Invitational (open or closed) – Two or more Days

\$100 Approved Meet – One Day

\$150 Approved Meet – Two or more Days

Rationale: The amount of work required to sanction a meet is identical regardless if the meet is open or closed.

Effective: Sept. 1, 2011

Discussion: A friendly amendment to move Triangular meets to the \$50 level.

Motion. Second. Approved as amended.

Election of Officers

A slate of officers was submitted. A motion was made to add Jennifer Van Meter to the Nomination Committee. A correction to Cathy Bishop was made, from representing QCA to Unattached. A reminder to all that ISI rules states no more than two club members may be on the ISI board.

Motioned. Second. Approved slate for election of officers with addition of Jennifer Van Meter.
