Zones Information- Judy Hackney reported for Eric Follmuth. The coaches have been selected for the 2006 Zone Meet. The Head Coach is Mark Corley and Assistant Coaches are Thad Hackney, Aron Nakama and Carissa Rabel.

Proposal A-Separation of the Iowa Summer State Swimming Championships (Dave Joensen – ISI Technical Planning)

Proposal: The Iowa Summer State Swimming Championships shall be divided into two separate championship meets to be titled the Iowa 12 and Under Summer State Swimming Championships and the Iowa Summer State Swimming Championships. All aspects of the current meet invitation shall be applied to the newly created meets with the exception of warm-up times, competition times, and order of events.

Rationale: The format of the Iowa Summer State Swimming Championships is no longer conducive to excellent performances. Senior swimmers are required to be at the pool early and stay late. Age Group swimmers are rushed through to maintain the timeline. Meet workers are pressured to maintain the timeline. A split of the Summer Championships into two meets would provide two meets, which can offer an excellent environment for championship swimming.

Discussion:

There is a correction scratch 13 and older. By separating the meets it would be on two separate weekends. A better alternative would be to lengthen the meet or limit the number of events. This would force one meet to be outdoors. Move the eight and unders back to regionals. ISI coaches endorsed this proposal earlier. Since there was much discussion a vote was taken. Yeas: 13 Nays: 12

Proposal A passed

Proposal B – The order of events for the Iowa 12 and under Summer State Championships (Dave Joensen – ISI Technical Planning)

Proposal: The following shall be the warm-up times, competition times and order of events for the Iowa 12 and under Summer State Swimming Championships. Friday, Saturday and Sunday warm-up time is 12 noon and Competition is 1pm. This would be in effect for the 2008 meet.

Discussion: None **Proposal B Passed**

Proposal C is withdrawn by Dave Joensen.

Proposal D- 13-14 and Senior State Championships- Order of Events (Barry Neville –Senior Meet Task Force Aron Nakama, Kelly Nordell, Al Panec)

Proposal: Change the order of events for both the Iowa Short Course and Long Course 13-14 and Senior State Swim Championships to the following Order of Events. This would go into effect for the March 2007 State Meet.

Discussion: A friendly amendment is proposed that the awards be taken out of the meet and be left up to meet management and that breaks between events would be determined by the meet referee. A motion is made to accept the amendment 1st Dave Joensen 2nd Dave Langer Motion carried.

Proposal F – Communications- Electronically (Jan Lawler ISI Administrative Vice Chair)

Proposal: To utilize e-mail for communication to reduce postage cost. Clubs could request hard copies if needed.

Rationale: These guidelines would reduce postage and copying expenses for clubs and ISI.

Discussion: This was discussed at the last board meeting in March. A friendly amendment is proposed under final results post PDF file on the web and then e-mail C file to clubs. Under meet invitations include team manager, order of events in the meet information to be mailed out. A motion is made to accept the amendment 1st Doug Kolsrud 2nd Jan Baker. Motion carried.

Discussion: A request is made that hard copies be sent out once per year with club registration through ISI.

Proposal F passed as Amended.

Proposal G: Event Invitations (Donny Spellman)

Proposal: To clear up event invitations a timed final meet could have 5 individual events per day and only 4 events per session (this lines up with the National Rule) and Novelty meets exception is five events per session.

Discussion: ISI swim coaches endorse this proposal.
