Proposal A: Separation of the Iowa Summer State Swimming Championships

Iowa City Eels Swim Club

Proposal: Motion to reconsider the separation of Long Course Championships into two separate age group meets on consecutive weekends.

Rationale: Additional information has become available which should be shared with the membership on the last meeting's motion with respect to this topic.

Motion to accept reading Proposal A Jim Broghammer

The University of Iowa pool will be ready in 2009. Iowa City will not allow the Iowa City Eels to close Mercer Park pool two weekends in a row. After much discussion at the coaches meeting there is a motion to table further discussion to the April Bid Meeting which is April 14, 2007.

Proposal B: Psych Sheets for Championship Meets

Proposal: Psych sheets for the ISI 12 and under Championships, ISI Short Course Championships and ISI Summer State Swimming Championships shall be posted on the Internet on the host's club website and or the ISI Website and sent to the entering clubs entry person.

Rationale: Posting of entries provides a service to the swimming community and also allows proofreading of entries.

Motion to accept reading Proposal B Barry Neville

Posting the psych sheets will minimize errors and parents can look to see if there are problems. If there are any late entries they can go in a 0 heat.

Proposal C: Over Entering Events at the ISI 12 and Under Championships

Proposal: To allow over entering events at the ISI 12 and under Championships

There were three changes a) swimmers may enter all events for which they are eligible and for which they possess the ISI Q Times. b) events will not be seeded until after the scratch deadline for a specific session. c) late entries will be due prior to the scratch deadline

Rationale: To establish consistency in entry procedure for the ISI Championships

Motion to accept reading Proposal C Mary Campbell

Discussion stated that the consequences are harder because the scratch deadline is earlier. There is no benefit too many time line issues. The coaches committee cannot endorse this proposal.

Proposal D Judy Hoffman Scholarship

Proposal Part I: The stipulation that the Judy Hoffman Award be given to a greater Des Moines area swimmer shall be eliminated.

ISI Codebook: L-III-B.1.b One Judy Hoffman award will be given annually.

Proposal II: Select one of the two options:

- a) The amount of the Judy Hoffman Award will be equal to the amount of the ISI Awards
- b) The amount of the Judy Hoffman Award will be greater that that of the ISI Awards and will be determined by the Scholarship committee with approval by the ISI BOD.

Rationale: The money donated by the Hoffman family for the scholarship use has been utilized. Money in the Judy Hoffman fund has come from ISI funds. Questions have been raised regarding ethics of all ISI members contributing to a scholarship fund for Des Moines swimmers only. Out of respect for Mrs. Judy Hoffman and her family, ISI wishes to offer a scholarship in her name but open up eligibility to ISI swimmers who meet the nomination criteria.

Motion to accept reading Proposal D Mary Studer

The history of the scholarship was explained by Dave Joensen however there was some discussion to the proposal regarding the amount of all scholarships to be \$600 each.

It was suggested to have the scholarship committee come up with amounts to be given. 1st Phil Barnes 2nd Nick Lakin.

Proposal: Meet financial summary report (APP-11) currently going to the ISI office within 45 days following the meet. Add a copy to be sent to the ISI Administrative Vice Chair.

Proposal I: Mandatory Fly Over Starts

Aron Nakama

Proposal: Proposal to make fly over starts mandatory for all meets with the exception of finals at prelims/finals swim meets.

Rationale: To make starting procedures consistent for all meets. There exists a lot of confusion at meets whether or not we are doing fly over starts. Fly over starts are intended to decrease the time of a swim meet. When confusion exists officials are asking swimmers to stay in the water. At smaller meets that do not need to run quickly flow of meet is usually decided by meet referee as well as breaks not listed in meet information.

Proposal J: Increase Entry Fines

Proposal: Increase entry fines from \$10 to \$50 for not meeting the qualifying times at the regional and state meet and not being able to prove the times.

Rationale: Takes away integrity of the sport and slows down the meet.

Amendment to increase the fine to \$100 for not being able to prove the time.
