Izaak Hajek and Bailey Hinkhammer missed the first three board meetings of the LSC's fiscal year. The board secretary has emailed these board members to see if they intend to continue serving on the board and if they wanted to request a waiver for their absences. As of now, these emails have not been answered. Per ISI Bylaws 6.8, these multiple absences without waivers constitutes their resignations from the board.

This leaves the board with only two voting athlete members. USA Swimming requires athlete membership to be at least 20 percent or at least three athlete reps for board with 11-15 members. IASI board does have one Junior athlete representative, but this position is a non-voting position unless one of the senior athlete representatives are not present. With the board in need of another athlete member, Mikayla Kloth has been nominated by Michael Peterson to be named as an athlete at-large board member with a term that runs through August 31, 2021.

 - Motion requiring two thirds vote presented to the board by Phil Barnes: With USA Swimming membership fees
 purchased to IASI for 2021, IASI will increase the LSC's portion of these membership fees by \$1.00 for the Premium,
 Seasonal and Non-athletes memberships
 - Motion for the board to pass the 2020-2021 budget as presented to the board by the Finance Committee presented by Phil Barnes. If the budget is approved by the board, it will then be presented to the LSC's HOD for its approval in April.
 - Motion to set the reimbursement rates for the 2020-2021 ISI Championship Meets:
 - The reimbursement rate for 2020-2021 Championships meets shall be set at no more than 50 percent
 of facility rental fees. Rental fees include facility rental fees along with all other fees associated with
 the rental such as timing system rental fee, custodial expense and lifeguard expenses.
 - If the 2020 ISI Short Course Championships and the 2020 ISI Age Group Short Course Championships
 have different numbers of splashes, individual event entries plus relay event entries, the
 reimbursement amounts will be set at the following:
 - The reimbursement amount for the host club of the meet with the greater number of splashes will be 50 percent of the fees paid by the LSC for that facility rental
 - The larger meet's reimbursement amount divided by that meet's number of splashes is the "splash rate"
 - The reimbursement rate for the host club of the smaller meet will be the lesser of the following:
 - 50 percent of the meet's facility rental fees
