### ISI Policies and Procedures – Section I 3 E

- E. Changes to the Annual Schedule of Meets after HOD Approval. Once the Annual Schedule of Meets is approved by the HOD, meets may be added, changed, moved or removed from the schedule, provided the club has met the following conditions:
  - 1. Notification. The club must notify the Senior Vice Chair and the Admin. Vice Chair of the change in writing and a copy of the notice of the change must be sent to the ISI Office. Iowa Swimming Inc. Section I Page: I-6 Policies & Procedures MEET OPERATIONS RULES Revised: 10/31/2018
  - 2. Add or Change Fee. The club shall pay the applicable sanction fee and an additional fee equal to twice the applicable sanction fee for the type of meet that is being added, changed, moved or removed from the meet schedule.
  - 3. Exceptions. If circumstances beyond the club's control are the cause of the removal from the meet schedule, the club shall notify the Senor Vice Chair and Admin. Vice Chair and a copy of the notice shall be sent to the ISI office. They will then recommend to the Board of Directors if suspension of the additional fee is warranted. Suspension of the fee is voted upon by the ISI Board of Directors.
