  - Request from Big Six Possible motion to change Splash Fee charges:
    - 1. Reduce the splash fee to a lesser amount for intrasquad? \$1 or \$2/meet?
    - 2. Charge a single splash fee of \$5/swimmer per sanction number. Thus, if a single sanction number is given to a team for all their intrasquad meets for a given season a single fee is assessed for each registered swimmer on the team, regardless of the number of internal meets during the specified period.

- Season shall be defined by three ten-week seasons with dates defined by the Age Group Development Committee not later than February 15 annually.
- Athletes shall be limited to participating in four Development competitions per season.
- Development competitions may operate as multi-day, multi-session meets. Sessions shall be planned to allow the events not to exceed two (2) hours in length. Athletes shall only participate in one session per sanctioned competition.
- Competitions may be composed of events selected from the following recognized list of events: 12 Years and Younger 25, 50, 100 freestyle 25, 50 backstroke 25, 50 breaststroke 25, 50 butterfly 100 individual medley 100, 200 freestyle relay 100, 200 medley relay 100, 200 mixed competition category freestyle relay 100, 200 mixed competition category medley relay
- Minimum Number of Officials Required for Development, Dual and Intra-Squad Meets:
  - 1 Referee, who may also act as a stroke and turn judge, 1 Starter, 1 Other Stroke and Turn Judge (may be the Starter), 1 Announcer, 3 Timers per lane (one minimum if automatic timing equipment with touchpads is used), 1 Administrative Official, 1 Place Judge, Relay Take-off Judges (if applicable,) Timing Equipment Operators (as needed), Marshal(s) (number determined by the LSC)
- Set dates for Developmental Competition Program for 2022 through February of 2023
  - May 9-July 10, 2022
  - October 3-December 11, 2022
  - December 12, 2022-February 5, 2023
- Suspend the restriction on non-IASI teams from entering during the first seven days that entries are being accepted through the 2022-2023 season as long as the team requesting entry within the first seven days entries are being accepted participated in the same meet during the 2019-2020, 2020-2021, or 2021-2022 seasons.

IASI P&P Section I. Meet Operation Rules, VIII. Specific Meet Operating Rules, C. Entry Deadlines: Only IASI clubs and Non-IASI member clubs that attended the meet the previous year may enter the meet during the first seven days that entries are being accepted. All teams can submit entries during the first seven days.

Rationale: COVID prevented non-IASI teams from normally participating in IASI meets since the 2019-2020 season. As meet schedules return to normal, teams from outside IASI who have supported IASI meets are requesting access to enter meets as if they had participated last year, if they participated in the last year they were allowed to enter.

 Approve the IASI Personnel Committee NDA and require all members of the IASI Personnel Committee agree to the terms.

• Reinstate IASI P&P Section I. VIII. M. 3. e. General Warm Up procedures effective immediately

IASI P&P Section I. Meet Operation Rules, VIII. Specific Meet Operating Rules, M.3.e. General Warm-Up

On July 1, 2020 the IASI Board of Directors voted to suspend the IASI rules regarding warm up procedures in response to COVID-19. Now that swimming is making every effort to restore pre-pandemic processes, the board should reconsider that action.

- Approve the order of events for the 2023 Championship Meets.
  - SCY Age Group Championships remains the same, except move the 13-14 mile fastest heats after the 11-12 100 IM to create a separation from the 11-12 200 breaststroke
  - SCY Senior Championships remains the same as this season
  - **LCM Championships** remains the same as the format bid for 2022 (this meet is 16 months away, so adjustments could still be made by the BoD)
- Move to Closed Session
  - Nomination for 2022 Outstanding Service Award
- Adjournment
