#### • Significant changes in this version:

#### • Paid Hours:

- Current staff is paid for an assumed number of hours per week (varies based on position). If their actual hours exceed their assumed hours, they receive additional compensation which includes overtime if they exceed 40 hours in a single week.
- Proposed employees track their hours worked through Gusto, the payroll/HR software we implemented 10-1-22, and they are paid for the hours they actually worked including overtime if applicable. Gusto is ideal for this process as it designates the ADVC to review and approve time reports and they automatically sync to the payroll system controlled by the Treasurer.

### • PTO (Paid Time Off):

- Current Each employee has 10 "days" of vacation, but does not define what a day is. Since our staff have the flexibility to set their own schedule, defining a "day" is nearly impossible.
- Proposed A graduated PTO policy defined in hours. Employees in the first 5 year of service get the equivalent of 2 weeks PTO, after 5 years it increases to 2.5 weeks PTO, and after 10 years it reaches a maximum of 3 weeks PTO. Since existing staff are all between 5 and 10 years of service, each staff member will get an additional ½ week PTO over the current level. The Committee believes that the additional PTO is sufficient consideration for the loss of "guaranteed" hours. The ADVC has discussed this concept with staff and they like the flexibility PTO provides. All PTO is requested, approved, and tracked through Gusto.

#### • <u>Vacation Days</u>:

- Current 7 recognized holidays: New Years Day, Memorial Day,
   Independence Day, Labor Day, Christmas Day plus two "floating" holidays
- Proposed 7 recognized holidays: Same as current holidays with the addition Day after Thanksgiving and Christmas Eve Day but the removal of the floating holidays

#### Pay Day:

- Current Since working hours are assumed, employees are paid on the last working day of each month.
- Proposed Since actual hours must be worked, reported and then approved, pay day would be moved to the 10<sup>th</sup> of each month to be paid for the work performed the previous month. This proposed change has been discussed with the staff and they do not have any issues with the new process.
