Technical Planning Committee - Ethan Johnston:

The TPC met this afternoon to discuss meet formats for the 2025 championship season. The committee approved going back to a 3,5 day meet for Age Group Championships. TPC will make a recommendation to the board to approve an increase in relay fees for 2025 championship meets from the current \$12 fee to a new fee of \$16. The fee for individual events will remain at \$8 per entry. The next TPC meeting will be held on March 3rd. At this time, TPC will finalize the template for the 2024 LC Championship Meet Invite to be sent to Sanctioning.

Diversity, Equity, and Inclusion - Don Spellman:

Meet information for the Multicultural Meet should be ready to go out soon. The meet committee will be meeting to finalize details shortly. IASI should plan on sending 2 coaches.

Registration - Jen Matthews:
