Significant changes include the following:

Revenue - reduction in budget of just over \$30,000 - major updates:

- 1. Our interest income is slightly down lowered the budget number
- 2. Splash fees reduced to \$1 for intrasquad and dual meets and \$4.50 for all other sanctioned meets

Expenses - increase in budget of just under \$28,000 - major updates:

- 1. Adjusted office salaries to reflect the current burn-rate, forecast through August 31, and a slight pay rise (this offset the reduction in splash fees)
- 2. Added a new computer for the office (need two, not one)
- 3. Reduced the banquet and awards budget to reflect actuals
- 4. Add cost of on-site facilities for board and HOD meetings

- 5. Increased the convention budget slightly to add a person
- 6. Increase athlete travel reimbursement by \$2,000
- 7. Updated all stars to reflect actual costs (there was a spreadsheet error in the original that I fixed)
- 8. Added \$6000 to Zones OW this is for the LSC open water meet in July 2026 there's no line item currently there. I would see this transitioning to a positive revenue event, and in future years, teams may look to take this on. Added another \$500 for other OW items
- 9. Added \$6,500 to Diversity and Inclusion for the disability committee \$5000 for grants to clubs for items supporting disabled swimmers (e.g., remote strobes, tappers) and \$1,500 for the committee's support of swimmers with disabilities.
- 10. Increased Coach development to \$5000 for a coaches' clinic supported by USA Swimming for junior and assistant coaches.
- 11. Added \$10,000 for age group swimmer development the age group committee is to host two events for age group swimmers
- 12. Increased the select camp budget to \$8,000 for two select camps one age group and the other senior.
- 13. Added \$5,000 for club development grants to clubs
- 14. Added \$2,500 to support the Women Coaches in Governance initiative
- 15. Added \$10,500 for officials, including paying for background checks (which will offset this cost from most clubs), a white polo for each official, and reimbursement for zone and OW clinics
